It is submitted that the Government of India vide reference 6<sup>th</sup> cited has conveyed Central Government **in-principle (Stage.I) approval** under Section 2 of Forest (Conservation) Act, 1980, for diversion of **4.698 ha** of forest land in Adilabad forest division - for laying of Pipelines and construction of Structures for **Segment-21/2 (Chenchughat)** under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal. The above orders have been communicated to all the concerned officers with instructions to submit condition-wise compliance report in the matter, vide reference 7<sup>th</sup> cited.

Accordingly, the District Forest Officer, Adilabad/ Forest Divisional Officer, Adilabad has obtain compliance of conditions from the User Agency and submitted the condition-wise compliance report together with its enclosures through I/c Conservator of Forests, Adilabad, which is received in this office through reference 8<sup>th</sup> cited. A copy of reference 8<sup>th</sup> cited together with its enclosures **in triplicate** are enclosed herewith.

The condition wise compliance report is reproduced as follows:-

(iv)	The State Government has proposed 4.698 ha of non-forest land for compensatory afforestation under the subject proposal as part of 187.677 ha of non-forest land identified for entire TDWSP projects (Mission Bhageeratha Project). <b>To supervise and Monitor the CA land, State Government shall demarcate the 4.698 ha of non forest land with DGPS coordinates. The co-ordinates, map, CA scheme and soil suitability certificate etc shall be uploaded in the Ministry's web portal against the subject proposal.</b>	Out of <b>187.677 ha</b> identified in 3 survey numbers i.e., Peddamunagala (Sy.No.169), Thimmapuram (Sy.No.139 &147)] in Chandampet Mandal of Nalgonda District for CA, under jurisdiction of the FDO, WLM Division, Nagarjunasagar, the non-forest land to an extent of <b>4.698 ha</b> is demarcated with DGPS coordinates. (vii)	Non-forest land which is transferred and mutated in favour of the State Forest Department for the purpose of compensatory afforestation, shall be declared as Reserved Forest under Section-4 or Protected Forest under Section-29 of the Indian Forest Act, 1927 or under the relevant Section(s) of the local Forest Act. The Nodal Officer must report compliance within a period of 6 months from the date of grant of final approval and send a copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the local Forest Act as the case may be, to this office for information and record;	The non-forest CA land transferred & mutated in favour of State Forest Department will be declared as PF/ RF under Telangana Forest Act, 1967 within a period of six months upon receipt of Stage II approval.

(viii)	The State Government shall charge the Net Present Value of the diverted forest land measuring 4.698 ha from User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995.	The User agency has deposited an amount of Rs.37,72,494/- (part of Rs. 1,06,27,794/- with UTR No. IDIBR52017100615067091 Dt: 06.10.2017) towards Net Present Value, into the account of TELANGANA STATE Ad-hoc CAMPA, New Delhi, against the project proposal No. FP/TG/WATER/18314/2016 <b>and same is reflected online.</b>
(ix)	Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from User Agency.	The User Agency has agreed and submitted undertaking for additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future will be deposited.
(x)	The funds received from the User Agency towards Compensatory Afforestation and Net Present Value under this project shall be deposited in the respective bank account of Telangana State CAMPA. <b><u>The User Agency shall compulsorily deposit the CA and other levies only by generating challan through the Ministry's website.</u></b>	The User agency has generated a challan through the Ministry's website for an amount of <b>Rs.68,55,300/- + Rs.37,72,494/-</b> (out of Deposited amount of Rs.1,06,27,794/-) towards CA and Net Present Value under this project including levies towards mitigation measures for the forest conservation etc and deposited the same into the Ad-hoc CAMPA account of TELANGANA STATE, with UTR No. IDIBR52017100615067091 dated 06.10.2017, against the project proposal No. FP/TG/WATER/18314/2016.
