

The payment for CA & NPV is to be made online through PARIVESH as stipulated at condition No.2(A) 1,2 & 3 of In-Principle Approval dated 14.10.2022 and IRO Shillong's letter dt.01.12.2022. As per condition No. 7 & 8, the cost of felling of trees amounting to Rs. 46,160.00 and boundary demarcation amounting to Rs. 67,000 may be deposited to State CAMPA Account No. 40036259239 (State bank of India, Khatla Branch) for implementation of project activities.

Further, in compliance to IRO, Shillong letter No. 3 - MZ C 038/2022-SHI/2544-45 Dt.01.12.2022, IPA condition No. 2 B. 2. is read as 'Compensatory Afforestation shall be taken up by way of planting ten times the number of trees likely to be felled (subject to a minimum of 100 nos) at Serhuan Hmunhlui, Tlabung Forest Range under Tlabung Forest Division at the cost of Rs. 1,09,471'.
