I submit that the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, in the reference cited (copy enclosed), has furnished the statutory proforma proposal under Forest (Conservation) Act, 1980, for diversion of forest land over an extent of 3.96 ha in Compartment No.313, Gulamaliabad South Reserve Forest, Dhone Range, Kurnool Division & District in favour of Sri Y.Mahendranath Reddy, Banaganapalli (V) & (M), Kurnool District for grant of quarry lease for Road Metal.

2. I am to inform that the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, has stated that the User Agency i.e., Sri Mahendranath Reddy, has initiated a proposal in the PARIVESH portal on 22.01.2021 for seeking prior approval of the Central Government under Forest (Conservation) Act, 1980 for diversion of forest land over an extent of 3.96 ha in Compartment No.313, Gulamaliabad South Reserve Forest, Dhone Range, Kurnool Division & District in favour of Sri Y. Mahendranath Reddy, Banaganapalli (V) & (M), Kurnool District for grant of quarry lease for Road Metal. The User Agency has justified that this particular variety of Road Metal is uniquely available in the applied forest area and not available anywhere outside the forest area. The User Agency has furnished RoFR Certificate in form-II as prescribed under the Forest (Conservation) Act, 1980, issued by the District Collector, Kurnool District and also undertakings to bear the cost of raising and maintenance of compensatory afforestation in the identified CA land, payment of N.P.V, Addl.NPV and cost of tree extraction charges etc.

3. Further, I inform that the Divisional Forest Officer, Kurnool has recommended the proposal in part-II. The Conservator of Forests, Kurnool Circle, Kurnool has agreed with the information given in part-II by the Divisional Forest Officer, Kurnool and also recommended the proposal in part-III. The Nodal Officer(FCA), Andhra Pradesh, has recommended the proposal in Part-IV. Accordingly, State Government recommends the proposal in Part-V, which is enclosed herewith.

I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under Section-2 of Forest (Conservation) Act, 1980, for diversion of forest land over an extent of 3.96 ha in Compartment No.313, Gulamaliabad South Reserve Forest, Dhone Range, Kurnool Division & District in favour of Sri Y. Mahendranath Reddy, Banaganapalli (V) & (M), Kurnool District for grant of quarry lease for Road Metal, at the earliest.
