The Demand Note was rejected on the Parivesh portal with the following comments:


1. NPV is not applicable as per the current guidelines.
2. Labour rate has been increased from 259 to 285 per MD; hence, the CA Schme should be revised accordingly.

उक्त टिप्पणी के आधार पर आपने अपने पत्र दिनांक 03.03.2025 से संशोधित मांग पत्र जारी करने के लिए निवेदन किया है जिसके क्रम में लेख है कि वन भूमि के 0.06 हैक्टर वनभूमि प्रत्यावर्तन एवं बिना वृक्षों के पातन की सैद्धान्तिक स्वीकृति भारत सरकार के संदर्भित पत्र द्वारा जारी की जा चुकी है। साथ ही आलोच्य प्रकरण में जब तक विधिवत स्वीकृति प्राप्त नहीं हो जाती है तब तक किसी भी प्रकार का गैर वानिकी कार्य किसी भी सूरत में नहीं होने देना सुनिश्चित करें अन्यथा आप व्यक्तिशः वन संरक्षण अधिनियम 1980 के दोषी होंगे।

1	The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, Demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost for works scheduled for subsequent years.	Deposit Cost of CA Rupees 478686/-



1	Legal status of the forest land shall remain unchanged.	Submit compliance.
2	Forest land will be handed over to the User Agency only after required non-forest land for the project is handed over to the User Agency.	Submit compliance.
3	Compensatory afforestation shall be taken up by the Forest Department over 0.25 ha (100 plants) degraded forest land village indrapura tehsil udaipurwati, District Jhunjhunu, Rajasthan at the cost of user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.	Submit compliance.
4	No Tree felling shall be involved in the implementation of this project.	Submit compliance.
5	The Pipeline shall be laid down 1.5 meter below the ground and after lying down of pipeline, the ground will be leveled.	Submit compliance.
