This office has given an "In Principle" approval for Proposal for grant of permission for laying Optical Fiber Cable along the routes mentioned hereunder. (Protected Forest Area) From Village Chokdi Bus Stand to Vanta Vachh Village on SH-21 Via Village Thoriyali Sudamada (Km.15.282 / Hac .0.687 ) in Surendranagar District vide this office letter No C/FCA/T.8/1623-26.Dt. 11/07/2018 .referred above at (2)

Reliance Jio Infocom Ltd has reported that it has deposited an amount of Rs7400/- towards the Cost of Registration Fee and processing Fee in the account of Govt. of Gujarat State Bank of India Gandhinagar .A/c No 66013423126 on Date 11/07/2018.The same has been confirmed by challan /bank receipt received vide letter dated 11/07/2018 of No C/FCA/T.8/1623-26.Dt. 11/07/2018 Reliance Jio Infocom Ltd

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act,1980, subject to the following conditions:-

1. The permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
3. Reliance Jio Infocom Ltd will have to obtain permission from this office for carrying out any maintenance works in future.
4. Reliance Jio Infocom Ltd will have make good the forest land after use/ maintenance work. No tree shall be cut.
5. Reliance Jio Infocom Ltd will be liable to make good any loss of Forests/Environment caused due to the use of the said land by the user agency.
6. Reliance Jio Infocom Ltd will seek permission from the Roads& Building Department/Science and Technology Department, Sachivalaya, Gandhinagar.
7. The Optical Fiber Cable.line will be laid underground in a trench of depth of 1 Mtr and width of 2 Mtr.in between rows of road side plantation.
8. Any other condition, which the Nodal Officer (FCA) may stipulate from time to time.
