This office has given an "In-Principal" approval for diversion of **1.7325** ha of protected forest land for laying of Optocal fiber Cable along the routes From 'T' Junction Santrampur Pratappura Circle to Saraswadi Chokdi Upto State Limit of GUJARAT / Rajsthan on SH 2A Via Village Bhukhi, Godhari Ni Muvadi, Ringaniya, Ghaswada (Km 38.500 /Hac.1.7325) for vide this office latter dated: referred aboved at (2).

The Reliance Jio Infocomm Limited, Ahmedabad has Reported that it has deposited an amount of Rs. 7400/- toward the cost of Processing Fee & Registration Fee (2400+5000=7400/-) in the 8782- Forest Remittance, account of Deputy Conservator of forest, Social Forestry Division, Godhra's D.D.O. The Undersigned is pleased to convey the formal Approval of the Government under Section-2 of the Forest (Conservation) Act, 1980 Subject to the following condition:

1. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
3. The user agency will have to obtain permission from the undersigned for carrying out any maintenance works in future.
4. The user agency will have to make good the forest land after use/maintenance work.
No tree shall be cut.
5. The user agency will be liable to make good any loss to Forests/Environment caused due to the use of the said land by the user agency.
6. The user agency will seek permission from the Road & Building Department/ Science & Technology Dept. Sachivalaya, Gandhinagar, if required so.
7. The line will be laid underground in a trench of depth of 1.65 Meters and width of 0.45 mtr in between rows of road side plantation.
8. Any other condition, which the Nodal officer (FCA)/the State Government may stipulate from time to time.
9. Work Will be carried out manually
10. User agency will be responsible for any loss to Forest/Environment caused due to the use of the said land by the User Agency.
