It is informed that, in the reference 1<sup>st</sup> cited, the Government of India, Ministry of Environment and Climate Change (Forest Conservation Division) dt:18<sup>th</sup> August,2021 has communicated In-principle / Stage-I approval of Central Government under Forest (Conservation) Act,1980 pertaining to Diversion of forest land over an extent of 0.14 ha in Compartment no.973, K.Polavaram RF Block, Yellamanchili Range, Visakhapatnam Division in favour of M/s. KSR Prince Hatcheries Ltd., Visakhapatnam for laying underground pipeline from Shrimp Hatchery to Bay of Bengal to draw sea

In this connection, the Authorized Signatory, M/s KSR Prince Hatcheries Ltd., Visakhapatnam is requested to go through the conditions stipulated in **Conditions from i to xix but the compliance in form of undertaking shall be submitted prior to Stage-II approval and also follow the instructions issued by the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur without any deviation.**

In the reference 2<sup>nd</sup> cited, the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur has instructed to issue demand notice to the user agency in the proforma communicated in Rc.no.45921/2001/FCA-4, dt:22.12.2017 for payment of NPV, CA etc., amounts to Adhoc-CAMPA through **e-payment mode i.e. challan generated through the Ministry's web portal (i.e. www.parivesh.nic.in) only**, as per the guidelines issued by the Ad-hoc CAMPA, New Delhi letter, dt:09.06.2016. The payment shall be made only in Corporation Bank.

In the reference 3<sup>rd</sup> cited, the Chief Conservator of Forests, Visakhapatnam has approved Compensatory Afforestation (CA) Scheme and specific scheme towards mitigation measures as per the condition no. 
