- 1. Publish the entire forest clearance granted in verbatim along with the conditions and safe guards, imposed by the Central Government in two widely circulated daily newspapers one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forestry purpose.
- 2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant officers of the Government who in turn has to display the same for 30 days.

Further, the User Agency has to furnish the compliance on the conditions stipulated in the Stage-I approval for onward submission to Government for obtaining Stage-II approval.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage-II) approval/working permission and no work in violation of F (C) act, 1980 and W (P) Act, 1972 shall be carried out.
