It is informed that, in the reference 1<sup>st</sup> cited, the Government of Andhra Pradesh, Environment, Forests, Science & Technology has communicated In-principle / Stage-I approval under Forest (Conservation) Act,1980 pertaining to Diversion of 4.36 ha of forest land in Compartment no.500, 507 & 508 of Ananthagiri RF-II, Visakhapatnam Division for formation and BT to the road including construction of culverts from Dabbagunta to Pallapudungada in favour of Executive Engineer, Panchayat Raj (PIU) Division, Vizianagaram. The same was communicated by the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur in the reference 2<sup>nd</sup> cited.



In this connection, the Executive Engineer, Panchayat Raj (PIU) Division, Vizianagaram is requested to go through the conditions stipulated in **Conditions from i to xxv but the compliance in form of undertaking shall be submitted prior to Stage-II approval and also follow the instructions issued by the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur without any deviation.**

In the reference 2<sup>nd</sup> cited, the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur has instructed to issue demand notice to the user agency in the proforma communicated in Rc.no.45921/2001/FCA-4, dt:22.12.2017 for payment of NPV, CA etc., amounts to Adhoc-CAMPA through **e-payment mode i.e. challan generated through the Ministry's web portal (i.e. www.parivesh.nic.in) only**, as per the guidelines issued by the Ad-hoc CAMPA, New Delhi letter, dt:09.06.2016. The payment shall be made only in Corporation Bank.
