Sikkim is a developing hilly state in the country having total area of 7096sq.km and population of about six lakh. To promote infrastructure development and to uplift the socio-economic status of the inhabitants as well as to maintain peace and tranquility amongst the citizen are the main aims of the State Government.

Public distribution System in the state caters to supply and distribution of Rice, Sugar and S.K. oil to various categorized beneficiaries like AAY (Antodaya Anna Yojana), PHH (Priority House Holds) after the implementation of National Food Security Act 2013. Food Godown is the place where these commodities are stored and are distributed through Fair Price shops. The distribution at Godown level is done by the Food Inspector to all the registered Fair price shops based on the online data of the beneficiaries. The Fair price shop then distribute the commodities to all the beneficiaries under their jurisdiction.

The present Food Godown is located at Soreng Bazaar which is creating problems to the bazaar beautification projects of Urban Development Department. The UDD is coming up with bazaar beautification project wherein the whole of Bazaar area will be beautified using floor tiles. The approach road leading to the Godown also falls under the project area.

Hence the public and Panchayats are pressurizing for early shifting of Godown to another suitable location. Further, there are no existing structures in the

proposed site which requires to be dismantled to facilitate the construction.
