With reference to the above cited letters on the captioned subject, it is to inform you GOI, MOEF and CC. Eastern Regional Office A/3, Chandrasekharpur, Bhubeneswar-751023 has conveys the Stage-I/in principle approval for diversion of 1.973 ha Revenue Forest land under Forest Conservation Act,1980 and guidelines in favour of M/S Karma Re-rollers Pvt. Ltd, Kapursing, Pihura in the District of Cuttack under this division for construction of Re-Rolling Plant for Manufacturing of TMT Bars/Rounds from ingots/ billets of 30000 tons per annum subject to compliance of 28 nos conditions prescribed therein so as to consider the Stage-II final forest clearance of the above project.
