Sub: Diversion of 1.3841 ha of forest land (Revenue Forest 0.123 ha + DLC forest 1.2611 ha) for construction of diversion portion of 400 KV Double Circuit Talcher-Meramundali Transmission line form LoC No. 29 to 32 due to be proposed new Railway line by East Coast Railways under Angul Forest Division by M/s PGCIL.

Sir,

In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, Eastern Regional Office, Bhubaneswar have accorded Stage-I approval vide their Letter No. 5-ORB432/2020-BHU dated 05.11.2020 in respect for diversion of 1.3841 ha of forest land (Revenue Forest 0.123 ha + DLC forest 1.2611 ha) for construction of diversion portion of 400 KV Talcher-Meramundali Double Circuit Transmission line form LoC No. 29 to 32 required due to be proposed new Railway line by East Coast Railways under Angul Forest Division, subject to fulfillment of twenty five (25) nos of conditions stipulated therein. Beyond this, Government of Odisha in F&E Department vide Letter No. 18832/ F&E dated 24.11.2020 have imposed 05 (Five) additional Conditions. The user agency has complied all conditions, excluding the condition of obtaining the requisite certificate under FRA-2006 from Collector concerned (for which undertaken once again to submit) as imposed by GoI, MoEF & CC as well as additional conditions imposed by State Government. The point wise compliance has been prepared basing on the reports of the DFO, Angul Forest Division and the RCCF, Angul Circle are as follows.

Condition (i) Legal status of the diverted forest land shall remain unchanged.

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that the legal status of forest land proposed for diversion will remain unchanged, which has been countersigned by DFO Angul and enclosed as **Annexure-I.**

Condition (ii): Forest land will be handed over only after required non-forest land for the project is handed over to the user agency.

Compliance:- In compliance to the above, DFO Angul Forest Division reported that the user agency has furnished an undertaking that the forest land will be handed over only after handing over of non-forest land in the project, which has been countersigned by DFO Angul & enclosed as **Annexure-II**.

Condition No-(iii): *Compensatory Afforestation shall be taken up by the State Forest Department over 2.7682 Ha of degraded forest land identified in Paranga RF under Angul Range of Angul Forest Division at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted using multi species, multi canopy intensive planting technique and monoculture of any species shall be avoided. A revised C.A. Scheme consisting of indigenous species to result in a multi canopy forest may be submitted before stage-II approval.*

Compliance:- In compliance to the above, RCCF Angul Circle has reported that degraded forest land twice to the extent of forest area to be diverted i.e. twice of 1.3841 ha equal to 2.7682 ha degraded forest land has been identified in Paranga RF under Angul Range of Angul Forest Division for raising Compensatory Afforestation with provision to take up ANR Plantation @ 600 plants per ha. The DFO Angul Division has furnished a certificate that the land identified is suitable for the purpose of Compensatory Afforestation to take up ANR Plantation @ 600 plants per ha.

The Compensatory Afforestation scheme has been technically approved by Principal (FD & NO, FC Act) with a financial outlay of Rs.5,23,100/- (Rupees Five lakhs twenty three thousand one hundred) only at wage rate of Rs.308/- per manday, copy of which is enclosed as **Annexure-IVb**. The scheme has inbuilt provision for multi-species plantation, avoiding monoculture copy submitted with proposal at Page 69/DP.

Condition No-(iv): *The cost of Compensatory Afforestation at the prevailing wage rate as per Compensatory Afforestation scheme and at the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.*

Compliance:- In compliance to the above, RCCF Angul Circle has reported that the Compensatory Afforestation scheme has been technically approved by Principal Chief Conservator of Forests (FD & NO, FC Act) with a financial outlay of Rs.5,23,100/- (Rupees Five lakhs twenty three thousand one hundred) only at wage rate of Rs.308/- per manday. As per approved C.A. Scheme the User Agency has deposited a sum of Rs 13,89,547.00 including Rs.5,23,100/- towards cost of CA, on 11.12.2020 vide UTR No. SBIN 220346806895 in Adhoc CAMPA in Corporation Bank, Lodhi Complex Branch, Block,11 CGO Complex, Phase-1 Lodhi Road New Delhi-110003 as per the demand raised by DFO Angul vide Letter No 8107 dtd 03.12.2020(**Annexure-IVc**). In this regard, the document in support of above payment is enclosed as **Annexure-IVa**. The approved scheme has got provision for 10 years maintenance and provision to cover anticipated increase in cost.

Condition No-(v): *The State Government shall charge the Net Present value(NPV) for 1.3841 ha of forest area to be diverted under this proposal from the user agency as per the Order of Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24.04.2008 and 09.05.2008 in IA No. 566 in Writ Petition (Civil) no. 202/1995 and as per the guidelines issued by Ministry vide its letter No. 5-1/1998-FC (pt.II) dated 18.09.2003, as well as letter No. 5-2/2006/FC dated 03.10.2006 and No..5-3/2007-FC dated 05.02.2009 in this regard.*

Compliance:- In compliance to the above, the DFO, Angul Forest Division vide his letter No. 8048 dated 30.11.2020 (Copy enclosed as **Annexure-Va**) has raised demand on user agency to deposit Rs. 8,66,447/- towards the cost of NPV through e-portal of MoEF & CC. The details calculation of NPV is mentioned below.

The user agency has deposited a sum of Rs 13,89,547.00 including Rs.8,66,447/- towards NPV ,on 11.12.2020 vide UTR No. SBIN 220346806895 in Adhoc CAMPA in Corporation Bank, Lodhi Complex Branch, Block,11 CGO Complex, Phase-1 Lodhi Road New Delhi-110003 as per the demand raised by DFO Angul vide Letter No 8048 dtd 30.11.2020(**Annexure-Va**).Copy in support of above deposit of Rs 13,89,547.00 is enclosed as **Annexure-V(b)**.

Condition No-(vi): *Additional amount of the NPV of the diverted forest land, if any becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the expert Committee, shall be charged by the State Govt from the user agency. The user agency shall furnish an undertaking to this effect.*

Compliance:- In compliance to the above, the user agency has furnished an undertaking that the Additional amount of the NPV of the diverted forest land, if any becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the expert Committee, shall be charged by the State Govt. from the user agency, with countersignature of DFO Angul Division the same is enclosed at **Annexure-VI**.

Condition No-(vii): *All the funds received from user agency under the project shall be transferred /deposited to State CAMPA fund only through (<http://parivesh.nic.in>)*

Compliance:- In compliance to the above, the user agency has reported to have deposited all the funds i.e. Cost NPV, Cost of Compensatory Afforestation and Cost of Dwarf Plantation in Ad-hoc CAMPA Account of Corporation Bank, CGO Complex, Lodi Road Branch, New Delhi-11003, the report of User Agency with Countersignature of DFO Angul is enclosed as Annexure-VIa. The details are given below:-

The prescribed 12 point CAMPA format showing deposit of above Compensatory levies realized from the user agency duly signed by the DFO, Angul and Chief Conservator of Forests(Nodal) of Office of PCCF & HoFF, Odisha has been appended as **Annexure- VI b**.

Condition No-(viii): *The user agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the user agency with State Forest department.*

Compliance:- In compliance to the above, the user agency has furnished an undertaking that they would restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under strict supervision of concerned DFO and the cost of felling of trees shall be deposited by the user agency with State Forest Department, which has been countersigned by DFO, Angul and enclosed as **Annexure-VII**.

Condition No-(ix): *The complete compliance of the FRA, 2006 shall be ensured by the way of prescribed certificate from the concerned District Collector. The FRA Certificate in Form-II (for linear projects other than plantation) shall be submitted before Stage-II approval.*

Compliance:- In compliance to the above, DFO Angul Forest Division vide his Memo No 4484 dtd 08.06.2021 has communicated the required FRA certificate in Form-I issued by Collector Angul District vide Letter No 846 dtd 30.04.2021 enclosing relevant documents like proceeding of meeting of concerned Forest Rights Committee , Grama Sabha, SDLC & DLC , certifying completion of identification and settlement of rights under FRA over the forest land of 2.3271 ha including Forest land of 1.3841 ha involved in this project & non- existence of recognized rights of PTGs & PACs. Copy of which, with countersignature of DFO Angul is enclosed as **Annexure-IX**. The content of certification, furnished by Collector Angul in the Form-I enclosed, is the same as that of prescribed Form-II as stipulated in the condition , hence the same may be considered as compliance.

Condition No-(x): *The User agency in consultation with the State Forest Department shall prepare a detailed scheme for Creation and Maintenance of Plantation of Dwarf Species (preferably medicinal species) in Right of Way under the transmission line, and provide Funds for execution of the said scheme by State Forest Department.*

Compliance:- In compliance to the above, as reported by the DFO, Angul Division, the scheme for creation and maintenance of plantation dwarf species (preferably medicinal species) in right of way under transmission line was approved by the RCCF, Angul Circle at the wage rate of Rs. 308/- MD amounting to Rs. 2,34,319/-. The DFO, Angul Division has raised demand to User Agency to deposit the amount Rs. 2,34,319/- towards the cost creation and maintenance of Plantation of Dwarf Species (preferably medicinal species) in Ad-hoc CAMPA Account vide his Memo No. 47 dated 04.01.2021(**copy enclosed as Annexure – Xa**). The user agency has deposited an amount of Rs.2, 34, 219/- in State Specific Ad-hoc CAMPA A/c No.150826438936352 vide UTR No. SBIN421011686503 dated 11.01.2021, which is enclosed as **Annexure-X b& X c.**

Condition No-(xi): *The user agency at its cost shall provide bird reflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.*

Compliance:- In compliance to the above, the user agency has furnished an undertaking that they would provide bird reflectors at their cost, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits, copy of which with countersignature of DFO Angul is enclosed as **Annexure XI.**

Condition No-(xii): *The user agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter No. 7-25/2012-FC dated 05.05.2014 and 19.11.2014*

Compliance:- In compliance to the above, the user agency has furnished an undertaking that they would abide with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter No. 7-25/2012-FC dated 05.05.2014 and 19.11.2014, which has been countersigned by the DFO Angul and enclosed as **Annexure-XII.**

Condition No-(xiii): *The user agency shall obtain Environmental Clearance as per the provisions of Environment (Protection) Act, 1980, if applicable.*

Compliance:- In compliance to the above, DFO, Angul has reported that the Environmental Clearance is not applicable for transmission line project, vide EIA notification dated 14.09.2006 , which has also been endorsed by RCCF, Angul and the user agency has also furnished and undertaking on non-applicability of the same, appended , which is enclosed as **Annexure-XIII**

Condition No-(xiv): *The layout plan of the proposed forest land shall not be changed without the prior approval of Central Government.*

Compliance:- In compliance to the above, RCCF Angul reported that the user agency has furnished an undertaking that they would not change the layout plan of the proposed forest land without the prior approval of Govt. of India, MoEF & CC, which has been countersigned by the DFO, Angul & enclosed as **Annexure-XIV**.

Condition No-(xv) No labour camp shall be allowed in the forest area..

Compliance:- In compliance to the above, RCCF Angul reported that the user agency has furnished an undertaking that no labour camp shall be allowed in the forest area, which has been countersigned by the DFO, Angul & enclosed as **Annexure- XV**.

Condition No-(xvi) Sufficient firewood, preferably the alternate fuel, shall be provided by the user agency to the labourer after purchasing the same from the State Forest Department or Forest Development Corporation or any legal source of alternate fuel.

Compliance:- In compliance to the above, RCCF Angul reported that the user agency has furnished an undertaking that they would provide sufficient firewood, preferably the alternate fuel, would be provided to the labourer after purchasing the same from the State Forest Department or Forest Development Corporation or any legal source of alternate fuel, which has been countersigned by the DFO, Angul & enclosed as **Annexure-XVI**.

Condition No-(xvii): The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.

Compliance:- In compliance to the above, RCCF Angul reported that the user agency has furnished an undertaking that while executing works no tree felling or damage to forest growth in surrounding forest area will be done any manner, which has been countersigned by the DFO, Angul & enclosed as **Annexure-XVII**.

Condition No-(xviii): The boundary of the forest land to be diverted shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.

Compliance:- In compliance to the above, DFO Angul reported that the boundary of the forest land to be diverted has been demarcated by the User Agency on the ground at project cost and the user agency has furnished an undertaking that the boundary of the forest land to be diverted has been suitably demarcated on ground at the project cost, as per GPS coordinates and direction of the concerned Divisional Forest Officer, which has been countersigned by the DFO, Angul & enclosed as **Annexure-XVIII**.

Condition No-(xix): *No additional or new path will be constructed inside the forest area for any activity related to the project work.*

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that no additional or new path will be constructed inside the forest area for any activity related to the project work, which has been countersigned by the DFO, Angul & enclosed as **Annexure- XIX.**

Condition No-(xx): *The period of diversion under this approval shall be co-terminus with the period of lease granted in favour of user agency or the project life, whichever is less.*

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that the period of diversion under this approval shall be co-terminus with the period of lease granted in favour of user agency or the project life, whichever is less, which has been countersigned by the DFO, Angul & enclosed as **Annexure-XX.**

Condition No-(xxi): *The forest land shall not be used for any purpose other than that specified in the project proposal.*

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that forest land will not be used for any purpose other than that specified in the proposal, which is has been countersigned by the DFO, Angul & enclosed as **Annexure-XXI.**

Condition No-(xxii): *The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without the prior approval of Government of India.*

Compliance:- In compliance to the above, DFO, Angul reported that the user agency has furnished an undertaking that the forest land proposed to be diverted under no circumstances will be transferred to any other agencies, Department or person without the prior approval of Government of India, Ministry of Environment, Forest & Climate Change, which has been countersigned by the DFO, Angul and enclosed as **Annexure-XXII.**

Condition No-(xxiii): *The State Government and the user agency shall ensure compliance to provisions of the all the Court Orders, provisions, rules, Regulations and Guidelines for the time being in force, as applicable to the project.*

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that they shall ensure compliance to provisions of the all the Court Orders, provisions, rules, Regulations and Guidelines for the time being in force, as applicable to the project, which has also been countersigned by the DFO, Angul and enclosed as **Annexure-XXIII.**

Condition No-(xxiv): Any other condition that this Ministry of Environment, Forest & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency.

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that any other condition that this Ministry of Environment, Forest & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area which shall be complied by the user agency, which has been countersigned by the DFO, Angul and enclosed as **XXIV**.

Condition No-(xxv): The compliance report of the Stage-I approval shall be uploaded on e-portal ([http:// parivesh.nic.in](http://parivesh.nic.in)).

Compliance:- In compliance to the above, RCCF, Angul Circle has reported that the user agency has furnished an undertaking that they would upload Stage-I compliance in the web portal of MoEF & CC ([http:// parivesh.nic.in](http://parivesh.nic.in)), which has been countersigned by the DFO, Angul and enclosed as **Annexure- XXV**

Additional State Govt. Stipulations

Condition No-(i) The sag and swing of the conductors are to be kept in view while working out the minimum clearance.

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that they shall certify that the sag and swing of the conductors, which are to be kept in view while working out the minimum clearance, which has been countersigned by the DFO, Angul and enclosed as **Annexure- XXVI**.

Condition No-(ii) No sagging of transmission line is allowed. The user agency shall certify in the month of March of every year that sagging, if any, has been corrected and further monthly report will be submitted by them till November of each year in the forest area to the DFO, for his reference.

Compliance:- In compliance to the above, DFO, Angul has reported that the user agency has furnished an undertaking that in the month of March of every year the user agency shall certify that sagging if any has been corrected and further monthly report will be submitted by POWERGRID till November of each year in the forest area to the DFO, Angul Division for his reference, which is enclosed as **Annexure-XXVII**.

Condition No-(iii) The User agency shall be allowed to fell the Trees on strips for the tension stringing work and the natural regeneration will be allowed to come up. Felling/pollarding/pruning of trees will be done with the permission of local Divisional Forest Officer whenever necessary to maintain the electrical clearance. One outer strip shall be left clear to permit maintenance of Transmission line.

Compliance:- In compliance to the above, DFO, Angul Circle has reported that the user agency has furnished an undertaking that they shall be allowed to fell the Trees on strips for the tension stringing work and the natural regeneration will be allowed to come up. Felling/pollarding/pruning of trees will be done with the permission of Divisional Forest Officer, Angul Forest Division whenever necessary to maintain the electrical clearance. One outer strip shall be left clear to permit maintenance of Transmission line, which has been countersigned by DFO Angul and enclosed as **Annexure-XXVIII**.

Condition No-(iv) *In the case of Transmission lines to be constructed in hilly areas, where adequate clearance is already available, trees will not be cut.*

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that in the case of Transmission lines to be constructed in hilly areas, where adequate clearance is already available, trees will not be cut, which has been countersigned by DFO Angul and enclosed as **Annexure-XXIX**.


Condition No-(v) *User agency shall take all measures for strengthening/maintaining the transmission tower and transmission line to be erected/laid on forest/non-forest land as per CEA norms for elephant corridor and any other conditions as may be imposed by CWLW, Odisha so as to ensure that no death of wild animals occur due to electrocution.*

Compliance:- In compliance to the above, DFO Angul reported that the user agency has furnished an undertaking that, they shall take all measures for strengthening/maintaining the transmission tower and transmission line to be erected/laid on forest/non-forest land as per CEA norms for elephant corridor and any other conditions as may be imposed by CWLW, Odisha so as to ensure that no death of wild animals occur due to electrocution, which has been countersigned by DFO Angul and enclosed as **Annexure-XXIX**.

In view of submission of the compliance to conditions imposed by the GoI, MoEF & CC, Eastern Regional Office, Bhubaneswar as well as the State Government, it is requested for consideration of according final approval for diversion of 1.3841 ha. of forest land for construction of diversion portion of 400 KV D/C Talcher- Meramundali transmission line from LoC No. 29 to 32 due to propose new Rail line by East Coast Railway by Power Grid Corporation of India, Talcher in Angul District, Odisha under Section-2 of Forest (Conservation) Act, 1980.


