Adverting to the subject and references cited, it is to inform that, Government of India, Ministry of Environment, Forests & Climate change, RO Chennai vide reference 1st cited has accorded in-principle (Stage-I) approval for Diversion of 11.584 ha of forest land for formation and improvement of road from Rechapally to Tatalvai Road from 3/0 to 10/0 in Jagtial District in f/o SE, R&B Division, Karimnagar, subject to the compliance of the certain conditions mentioned therein, which has been communicated to the Executive Engineer, R&B Division, Jagtial and Superintending Engineer, R&B Division, Karimnagar vide ref 2nd cited.

As per the conditions stipulated, the User Agency has to make the payment of the following Compensatory Levies into the accounts indicated:

The User Agency has to deposit an amount of Rs. 4,18,34,214/- (Rupees in words Four Crores Eighteen lakhs Thirty Four thousands Two hundred and Fourteen only through online mode only) in the State Compensatory Afforestation Fund of Telangana State through online.

Further the User Agency has to deposit an amount of Rs. 20,86,864/- (Twenty lakhs Eighty Six thousands Eight hundred and Sixty Four only) in CA PD account of DFO, Jagtial bearing number 025810100294226, Andhra Bank, Branch: Jagtial, IFSC Code: ANDB0000258.

Further the User Agency is also requested to intimate the details of payments made and submit seven sets of compliance report on all the conditions stipulated in Stage-I approval along with all the necessary documents, certificates, undertakings etc., for onward submission to the competent authority for issuance of Stage II approval.

Transfer of Forest Land proposed for diversion to the User Agency shall not be affected prior to the issue of final approval. This in-principle approval shall be valid for a period of (5) years. In the event of non compliance of the above conditions, this in-principle approval shall automatically stand revoked after (5) years.


