Pursuant to the MoEF & CC, Govt of India's letter F.No.3 AS B114/2022-GHY4441-42, dated 29.08.2023 (ref. Sl. No.1) granting "In Principle Approval/Stage-I" for diversion proposal of 3.92 ha. of forest land for development drilling wells and testing of Hydrocarbons in Duamara Block in Upper Dehing Reserved Forests (East Block) under Digboi Division in favour of Oil Max Energy Pvt. Ltd. and with reference to letter quoted under reference Sl. No. 2, it is requested to deposit 2% of the estimated project cost to the account of CAMPA.

- (a) Area of forest land proposed for diversion = 3.92 Ha.
- (b) Estimated cost of the project = Rs. 30,00,00,000
- (c) 2% of total project cost =  $0.02 \times 30,00,00,000 = \text{Rs.} 60,00,000$
