विषयः जनपद बिजनौर की तहसील नजीबाबाद के अन्तर्गत भारतीय राष्ट्रीय राजमार्ग प्राधिकरण मेरठ द्वारा नजीबाबाद—कोटद्वार मार्ग (एन०एच०–119) from 2 lane to 2 lane paved shoulder from Existing Chainage 120\_900 to 138+635 (Design Chainage 120+900 to 137+760) के चौड़ीकरण/ सुदृढ़ीकरण हेतु प्रभावित 27.33 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग एवं उस पर अवस्थित 5866 वृक्षों के पातन/ट्रान्सप्लान्ट की अनुमति के सम्बन्ध में।

महोदय,

कृपया उपरोक्त विषयक सचिव (वन), उत्तर प्रदेष शासन के पत्रांक पी–293 / 81–2–2022–800(301) / 2022, दिनांक 31.08.2022 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रस्ताव पर वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 के अन्तर्गत भारत सरकार की स्वीकृति मांगी थी।

प्रष्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 14.12.2022 द्वारा कतिपय शर्तों के साथ सैद्धांतिक स्वीकृति प्रदान की गई थी, जिसकी अनुपालना उपरोक्त संदर्भित पत्र के माध्यम से प्रेषित की गई है। प्रस्तुत अनुपालना के परीक्षणोपरान्त मुझे आपको यह सूचित करने का निर्देष हुआ है कि केन्द्र सरकार जनपद बिजनौर की तहसील नजीबाबाद के अन्तर्गत भारतीय राष्ट्रीय राजमार्ग प्राधिकरण मेरठ द्वारा नजीबाबाद—कोटद्वार मार्ग (एन०एच०—119) from 2 lane to 2 lane paved shoulder from Existing Chainage 120\_900 to 138+635 (Design Chainage 120+900 to 137+760) के चौड़ीकरण/ सुदृढ़ीकरण हेतु प्रभावित 27.33 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग एवं उस पर अवस्थित 5866 वृक्षों के पातन/ट्रान्सप्लान्ट की विधिवत् स्वीकृति निम्नलिखित शर्तो पर प्रदान करती है :—

1. Legal status of the forest land shall remain unchanged.

- 2. Compensatory afforestation shall be taken up by the Forest Department in an area of 55.00 ha Degraded Forest land in Compartment Chaura-8, Range Ramgarh, District Sonbhadra (25.00 ha). Devari Compartment No. 4, Range Machi, District Sonbhadra (20.00 ha) & Devari Compartment No. 4. Range Machi District Sonbhadra (10.00 ha) at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 3. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 4. User agency shall restrict the felling of trees to 5866 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 5. Plantation shall be raised on both sides of the road and median (if available) by the State Forest Department at the cost of User Agency according to IRC guidelines and order passed by NGT in OA no. 27/2015 in the matter of Babulal Jaju v/s State of Rajasthan and others dated 16.11.2015 as per submitted scheme.
- 6. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas.
- 7. The user agency shall provide suitable under / over pass in Protected Area / Forest Area as per recommendations of CWLW / NBWL / FAC / REC.
- 8. The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.

- The layout plan of the proposal shall not be changed without prior approval of Central Government. 10. No labour camp shall be established on the forest land.
- 11. The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- 12. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per
- 13. No additional or new path will be constructed inside the forest area for transportation of construction
- 14. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in
- 15. The forest land shall not be used for any purpose other than that specified in the project proposal. 16. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies,
- department or person without prior approval of Govt. of India. 17. User Agency shall construct the project within diverted land as per IRC specifications duly
- 18. The KML file of area proposed for diversion and area proposed for plantation shall be uploaded on the E-Green watch portal with all requisite details before commencement of works.
- 19. Annual 3rd party monitoring and concurrent internal monitoring by State Forest Department shall be done
- 20. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
- 21. Project Completion Report and Stage-II compliance report shall be submitted within a period of 6 months
- 22. The violation of any of the conditions stipulated under this approval will be liable to the cognizance and appropriate action under MoEFCC rules and Guidelines as applicable, specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is committed or violation of the provisions of the said Act has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Act or the violation of the rules made thereunder, in the court having jurisdiction in the matter.
- 23. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, (1980), and action would be taken as per the MoEF&CC Guideline F.No. 11-42/2017-FC dt.
- 24. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
