As per direction given in the letter cited above for diversion of 5.4525Ha of forest land for widening and strengthening to 2 lane with paved shoulders of Chapra-Baniapur-Malmalia-Mohammadpur Section (Km 1.5 - Km 14.50 & Km 30.00 - Km 34.075) of NH-101, the amount of NPV and CA of Rs.70,15,672.00(Seventy lac fifteen thousand six hundred seventy two rupees) only has been deposited in A/C of CAMPA, Bihar (A/C No. -150626132425668&UTR No.- P19061361309564) through e-challan (Copy attached).
