In compliance of the Ministry of Environment and Forest (MOEF) Government of India letter No.11-9/98-FC (pt) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of right under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition Of Forest Rights) Act 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purpose, it is certified that 0.226ha of forest land proposed to be diverted in favour of Divisional Forest Officer, Mumbai Mangroves Conservation Unit for Development of Mangroves Conservation Center and Mangrove Park in Mumbai Suburban district falls within jurisdiction of Village Gorai in Borivbali tahsil.

a) The complete process for identification and settlement of right under the FRA has been carried out for the entire **0.226 ha.** of forest land proposed for diversion. A copy of records of all consultation and meeting of the Forest Right Committee (Prabhag Samittee) are enclosed as Annexure - 01

b) The proposal for such diversion (with full details of the project and its implications, in vernacular /local

language) have been placed before Prabhag Samittee where forest dwellers are not found.

c) The each of concerned Prabhag Samittee has certified that all formalities /processes under the FRA have been carried out and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any having understood the purpose and details of proposed diversion. A copy of certificate issued by the Prabhag Samittee. (are enclosed as Annexure 01)

d) The discussion and decisions on such proposals had taken place only when there was a quorum of

minimum 50% of the members of Prabhag Samittee.

e) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and Prabhag Samittee have given their consent to it.

f) The Proposal does not involve recognized rights of Primitive Tribal Groups and Pre-agricultural communities, as per section 3(1) (e) of the FRA
