It is submitted that the Government of India in the ref.1st cited have accorded Stage-I approval for diversion of 0.99 Ha forest land in Compt. No. 132, Mangalagiri Block of Tadepalli RF in Guntur Division for construction of 132/33 KV Sub-Station, AIIMS at Mangalagiri in Guntur District in f/o EE, Construction Division, A.P., Transco, Guntur with certain conditions stipulated therein and requested to furnish the compliance report for according final approval for the project.

Accordingly, the Chief Conservator of Forests, Guntur vide reference 5th cited has submitted the condition wise compliance report on the conditions stipulated by the Government.

The condition wise compliance report is as follows.

Sl.No	Condition stipulated by GoI, Ir., dated : 20-06-2017	Compliance on condition
(i)	The legal status of the forest land shall remain unchanged.	: The user agency has given an undertaking to this effect
(ii)	The demarcation of the proposed forest area shall be carried out by erecting 4'-0" high cement concrete pillars duly numbered at an interval of 20 meters at the cost of the user agency	: The user agency has erected 20 nos cement concrete pillars duly numbered at an interval of 20 meters in the proposed diverted area.
(iii)	The State Forest Department shall raise and maintain two times the trees to be felled in the proposed forest land for diversion in nearby degraded forest land at the cost of the User Agency	: The User Agency has deposited an amount of Rs. 2.00 lakhs (Rupees Two lakh only) towards cost of raising and maintenance of plantation through RTGS on 28-03-2018 (Copy enclosed)

(iv)	The State Government shall charge the Net Present Value of the diverted forest land measuring (0.99 Ha) from the User Agency as per the orders of the Hon'ble Supreme Court of India dated : 28.03.2008 and 09.05.2008 in IA Nos 826in 566 with related IA's in Writ Petition (Civil) No.202/1995.	: The User Agency has deposited an amount of Rs.6.1974 Lakh (Rupees Six lakh nineteen thousand and Seven hundred forty only) towards cost of Cost of NPV through RTGS on 28.3.2018(Copy enclosed)
(v)	Additional amount of the Net Present value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the state Government from the User Agency. The User Agency shall furnish an under taking to this effect.	: The User Agency has given an Undertaking to this effect (Copy of the same is enclosed herewith).
(vi)	The funds received from the User Agency towards Compensatory Afforestation and the Net Present Value under this project shall be deposited in the Corporation Bank account of the Andhra Pradesh State CAMPA. The User Agency shall compulsorily deposit the CA and other levies only by generating the Challan through the Ministry's website.	: The User Agency has deposited an amount of Rs.8.1974 Lakhs towards cost of NPV & CA in the Corporation Bank account of the Andhra Pradesh State CAMPA through RTGS on 28.3.2018 (Copy enclosed).
(vii)	The User Agency and the State Government shall ensure compliance to Ministry's guidelines F.No 7-25/2012FC dated 5 th May,2014 and the provisions of the all Acts, Rules, Regulations and Guidelines of the Ministry, for the time being in force, as applicable to the transmission line projects.	: The user agency has given an undertaking to this effect.
(viii)	No damage to the flora and fauna of the adjoining area shall be caused while executing the project work.	: The user agency has given an undertaking stating that no damage to the flora and fauna of the adjoining area should be caused while executing the project work (Copy enclosed).
(ix)	The layout plan of the proposal shall not be changed without the prior approval of the Central Government. The User Agency shall furnish an Undertaking to this effect.	: The user agency has given an undertaking stating that the layout plan of the proposal should not be changed without the prior approval of the Central Government (Copy enclosed).
(x)	Trees / Bushes standing in the diverted area shall be felled / cleared strictly as per the requirement with the prior permission of the DFO Concerned.	: The user agency has given an undertaking stating that the Trees / Bushes standing in the diverted area shall be felled / cleared strictly as per the requirement with the prior permission of the Divisional Forest Officer, Guntur(Copy enclosed).

	translocate the trees, wherever feasible instead of felling at the cost of the User Agency.	: The user agency has given an undertaking stating that they shall pay the amount to translocate the trees, wherever feasible instead of felling (Copy enclosed).
(xii)	The total forest area utilized for the project shall not exceed 0.99 Ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal. The User Agency shall furnish an undertaking to this effect.	: The user agency has given an undertaking stating that the total forest area utilized for the project should not exceed 0.99 Ha and the forest area diverted should not be used for any purpose other than those shown in the diversion proposal (Copy enclosed).
(xiii)	The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the Central Government.	: The user agency has given an undertaking stating that the forest land proposed for diversion should under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the Central Government (Copy enclosed).
(xiv)	The approval under the Forest (Conservation) Act, 1980 is subject to the clearance under all other Acts, Rules / Regulations and Guidelines as may be applicable to such projects. The User Agency and the State Government shall ensure compliance to the provisions of Acts, Rules / Regulations and Guidelines for the time being in force, as applicable to the projects.	: The user agency has given an undertaking stating that the approval under the Forest (C) Act, 1980 is subject to the clearance under all other Acts, Rules / Regulations and Guidelines as may be applicable. We abide to ensure compliance to the provisions of Acts, Rules / Regulations and Guidelines for the time being in force, as applicable to the projects (Copy enclosed).
(xv)	The Progress of the Compensatory Afforestation as mentioned by the Divisional Forest Officer Guntur division in Sl. No 12 (v) (a) & (b) of part II i.e 591.945 Ha forest land and 68.382 Ha of non forest land shall be monitored by the Circle Head and a copy of such monitoring report shall be forwarded to the Regional Officer to upload the same in the web portal.	: The Circle head has monitored the Progress of the Compensatory Afforestation from time to time as per the prescribed guide lines. The monitoring report will be submitted separately.
(xvi)	Any other conditions that the Central Government or Additional Principal Chief Conservator of Forests (Central) of Regional office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User Agency.	: The user agency has given an undertaking stating they shall compile any other conditions imposed by the Central Government or Addl. Principal Chief Conservator of Forests (Central) of Regional office, Chennai from time to time in the interest of afforestation, conservation and management of flora and fauna in the area (Copy enclosed).
(xvii)	The User Agency shall submit the annual self compliance report in respect of the above conditions of the	: The user agency has given an undertaking stating that they shall submit the annual self compliance report in respect of the above conditions of the

	State Government and to the Regional Office, regularly.	State Government and to the Regional Office, regularly (Copy enclosed)
(xviii)	In the event of failure to comply with any of the conditions the User Agency is liable for penal action as decided by the Additional Principal Chief Conservator of Forests (Central), Regional Office, Chennai.	The user agency has given an undertaking stating that in the event of failure to comply with any of the conditions they are liable for penal action as decided by the Additional Principal Chief Conservator of Forests (Central), Regional Office, Chennai (Copy enclosed).

The condition wise compliance report on the conditions stipulated by the Government of India in their Stage-I approval has been obtained from the D.F.O., Guntur and Chief Conservator of Forests /Conservator of Forests , Guntur is submitted herewith.

The Government are requested to onward submit the same to the Government of India, MoEF &CC, RO, Chennai to accord final approval of the said project at the earliest.
