The Government of India under the ref (1) has accorded approval in-principal (Stage-I) under section 2 of Forest (Conservation) Act 1980 for diversion of 0.2808 ha. of forest land in F.sy.No. 297A1A1A1A of Shatageri village, Ankola Taluk for approach road to Stone Quarry in malki sy.no. 310 of Shetageri village in favour of M/s. Modern Road Makers Pvt. Ltd. Mumbai . Accordingly the Deputy Conservator of Forests, Karwar division has furnished the compliance report letter cited under ref.(3) as below:
