

IV	The State Government shall charge the Net Present Value of the diverted forest land of 0.2024 ha from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008 and 09.05.2008 in in IANos 826 in 566 with related IA's in WP(C)202/ 1995.	Complied
V	Additional amount of Net Present Value of the diverted forest land if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall be charged by State Government by the User Agency. The User Agency shall furnish an undertaking to this effect.	Will be Complied
VI	All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e_portal ( <a href="https://parivesh.nic.in">https://parivesh.nic.in</a> ).	Complied

VII	Necessary certificates/documents under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 and as per the guidelines issued by the Ministry of Environment, Forest & climate change vide letter No. 11-9/ 1998-FC(pt) dated 05.07.2013 shall be furnished before stage-II clearance. X	No additional or new path will be constructed inside the adjacent forest area for transportation of construction materials for execution of the project work.	Will be Complied
XI	The forest area shall be used for the purpose for which it is granted. The total forest area utilized for this project shall not exceed 0.2024 ha.	Will be Complied
XII	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.	Conditions will be strictly followed.
XIII	The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.	Will be Complied
