The Government of India vide Ref(1) has accorded 'in-principle'(Stage-I) approval under Section-2 of Forerst (Conservation) Act, 1980 for diversion of 0.98ha of forest land in Sy.No.79/P1 Sonnenehalli Village, Hesaraghatta Hobli, Bengaluru North (Additonal) Taluk, Bengaluru Urban District for construction of 400 kV D/C Quad Tumkur (Vasanthanarasapura)

to Yelahanka Transmission line in Bengaluru Urban District (and Forest Division) subject to certain conditions. The same was sent to your office for submission of compliance of the conditions of Stage-I approval.

- (1) With regard to condition No.A(2), the User Agency has to remit the Cost of raising plantation of ten times the number of trees to be felled – 114 trees (114 trees x 10 times = 1140 Trees) i.e. Rs.21,84,000/- as intimated by this office Demand Notice vide Ref(4). The same was remitted and the copy of the remittance challan was submitted to this office vide letter Ref(7) .

However, the Compensatory Afforestation charges have been revised vide O.M. No. A5(3).GFL.CR-28/2009-10(E-office File No.KFD/HOFF/A5-3(GFL)/34/2019-FC Dated: 24.05.2022.

The cost of Cost of raising plantation of ten times the number of trees to be felled – 114 trees(114 trees x 10 times = 1140 Trees)as calculated as per the rates revised in the above OM are

Actual amount to be remitted	Rs.23,12,000/-

The copy of the challan remitted should be submitted in duly 6 ink signed sets .

- 2) With regard to condition No.A(11), the copy of the specifications and the sketch of the boundary pillars is enclosed along with this letter, the User Agency is directed to construct such type of pillars each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates duly 6 ink signed sets to ths office.

The Compliance report submitted vide ref(7) is returned herewith and your kindself is hereby informed to comply the conditions as mentioned above and submit to this office at the earliest.



Stage-I clearance of Central Government has been received vide MOEFF & CC Letter No. 4-KRB1296/2021-BAN/268 dtd. 16.07.2021 for the above diversion of forest land. As per conditions stipulated in Stage-I clearance, an amount of Rs. 31,41,029/- has been deposited on 01.06.2022 (Copy enclosed) as NPV, cost of plantation and penalty against demand note No. A7.Land Lease.PG.CR-74/2019-20/491 dtd. 29.04.2022.

However, vide letter no: 2868 dated: 12.12.2022 DCF, Bengaluru Urban Division raised a Demand Note to pay Rs.1,28,000/- towards revised Compensatory Afforestation charges.

Hence, it is requested to kindly approve the Demand Note for raising challan for payment.

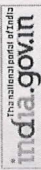
