No. 497 & 498 of Peddagudem beat, Compt No.499 of Savaigudem Beat of Peddagudem Section, in Wanaparthy Reserve of Wanaparthy Range Wanaparthy Forest Division under Wanaparthy District, for laying of Optical Fibre Cable along the road within the existing RoW for execution in favour of M/s Telesonic Networks Limited (UA) and as per latest guidelines issued vide GOI, MoEF, 21.08.2023, the following demand notice is hereby issued to the user agency as per revised rates for depositing the funds towards the following:

Further, it is informed that, as per latest guidelines issued by GoI vide F.No.FC-11/50/202/50/2020(3\_-Part (3); dated 21.08.2023 at SI. no 5, the UA has to seedlings and the cost of raising and maintenance of these plants in DFL areas has to be borne by User agency. The following funds towards raising plantation and maintenance has to be deposited through online in Ad-hoc CAMPA account through e-Payment Challan by the UA as detailed below:

The User Agency is requested to deposit an amount of Rs. 1,50,000/- in the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account, through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., http://parivesh.nic.in, by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at http://parivesh.nic.in

Further, it is also requested to deposit an amount of Rs. 12,10,000/-into the PD Account of District Forest Officer, Wanaparthy, as given above.

Further, it is requested to comply with the following in accordance with the MoEF&CC, GoI instructions issued vide F.No.7-23-2012-FC, dated 24.07.2013 communicated vide PCCF's Rc.No.45921/2001/F4, dt.23-08-2013:

- 1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the State government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
- The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

It is also requested to comply with the other conditions as directed in ref 7<sup>th</sup> cited and submit the compliance report on the conditions stipulated by the Govt. for obtaining Stage II (final) approval.

The UA is also directed to no to take any activity in the proposed site till working permission or Stage-II approval is accorded.

In view of the above, it is requested to kindly arrange to approve the demand notice for raising demand notice over the user agency.
