With reference to the subject cited above, in the reference (1) cited above, the Government of India, Ministry of Environment, Forests & Climate Change, Regional Office (South Eastern Zone), Chennai has accorded the stage-I permission for the diversion of 4.675 ha of forest land in Manuguru of Bhadradri Kothagudem District for laying of pipeline and construction of Structures in segment-25/1 (Radham Gutta) for providing safe drinking water under Telangana Drinking Water Supply Project in favor of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam.


