With reference to the above cited memo on the subject, it is to inform that as per condition No. (iv) of the GoI, MOEF & CC of stage-I approval of the above project and condition No. I of State Govt. F&E Deptt. Scheme for planting 10 times the trees to be felled for this project approved by the Regional Chief Conservator of Forests, Angul Circle vide his Memo No. 741 dt. 11.02.2019 for financial outlay for Rs. 2, 05,924/- (Rupees Two lakhs five thousand nine hundred twenty four) Only. implemented by Forest Department. Accordingly, demand was issued to the User Agency vide this Office Letter No. 995 dt. 14.02.2019, the approved amount has been deposited by the User Agency on dated. 26.09.2022.

There has been inordinate delay in the deposit of fund for implementation of plantation scheme. Due to this, the plan which was prepared for implementation from financial Year 2019-20, will be implanted from Financial Year 2023-24.

Further, the Principal Chief Conservator of Forests, Nodal, F.C., Act. O/o the Principal Chief Conservator of Forests, Odisha, Bhubaneswar has intimated that vide his Memo No. 2000 dt. 02.02.2023 the plantation scheme is revised and approved an amount of Rs. 4,18,048/- or rounded off Rs. 4,18,100/- (Rupees Four Lakh Eighteen Thousand One Hundred) Only. The financial outlay alongwith the revised cost norm for Block Plantation of 2470 nos of plants against 247 nos of trees to be felled from Government Revenue/ Forest land in village Bhaktipal upstream of Samal Barrage, District-Angul leased out to NTPC, Talcher Thermal, Angul is enclosed herewith for your reference.




Hence you are requested to deposit an amount of Rs. 2,12,176/- (Rs. 4,18,100/- - 2,05,924/-)= 2,12,176/-(Rupees Two Lakh Twelve Thousand One Hundred Seventy Six) Only towards the revise cost of approved scheme by the PCCF, Nodal, FC, Act. O/o the PCCF, Odisha, Bhubaneswar for 10 times the trees to be felled in. Ad-hoc CAMPA in the saving Bank Account No. 520101263743655 , Corporation Bank, Lodhi Complex, Ground Floor, Block No. 11, CGO Complex, Lodi Road New Delhi through "e " payment immediately and intimate the same to the undersigned for taking further action in the matter.


