

With reference to the subject & reference quoted above this is to inform you that IRO Kolkata has accorded Stage-I/ In-principle approval for diversion of 0.4278 ha forest land in connection with the Proposal No FP/WB/OFC/141578/2021 submitted from your end. The undersigned is directed by the Chief Conservator of Forests, FCA, to raise a demand note (**Condition: A**) for payment of cost of raising and maintenance of Compensatory Afforestation for 10 years (CA) & cost of Net Present Value (NPV) which is as given below:


