With reference to the above subject, the Ministry of Environment Forests and Climate Change, Government of India has accorded 'in principle' approval (Stage-I) under Section-2 of Forest (Conservation), Act-1980 for Proposal for ex-post facto approval for diversion of 96.868 hectare of forest land outside Mining Lease area (ML No.2396) of Donimalai(DM) Block Forest (Near Narsinghapura Village) in favour of Executive Director, M/s. NMDC Limited, Donimalai, Sandur Taluk, Ballari Karnataka, (FC Online Application No. FP/KA/Others/17464/2016) vide letter under reference(1).
