I submit that in the reference cited (copy enclosed) the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, has furnished statutory proforma proposal under Forest (Conservation) Act, 1980, for diversion of 3.63 ha forest land in Compartment No.347 & 348 of Chippapalli RF, Ananthagiri (M), Vizianagaram Division for formation of road from Gummakota to Galipadu in favour of Executive Engineer, Panchayat Raj (PIU) Division, Paderu.


2. In this regard, the Principal Chief Conservator of Forests & Head of Forest Force, has informed that the User Agency i.e., Executive Engineer, Panchayat Raj (PIU) Division, Paderu has uploaded the subject proposal in PARIVESH portal (Proposal No.FP/AP/ROAD/149544/2021) for seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980. The User Agency has justified that the villagers of Sankuparthi, Sunnapumamidi, Burjavalasa, Mettavalasa, Galipadu to reach the mandal head quarters Ananthagiri with shortest path by providing this road, the existing road passes through Reserve Forest in various reaches in the road from 0/00 to 8/200 km. This is the only the shortest route for the people of above habitations. The buses and commercial vehicles are not plying in this road due to improper geometry and various streams crossing the road. The people are facing lot of problems to meet their needs of Education, Health and Transportation of Agricultural and forest produces etc. The road is proposed to upgrade to BT standard so as to make the road traffic worthy. The User Agency has furnished RoFR Certificate in form-I issued by the District Collector, Alluri Sitharamaraju District and also undertakings for payment of NPV, Additional NPV, CA and tree extraction charges etc.

3. The District Forest Officer, Vizianagaram has recommended the proposal in Part-II. In Part-III, the Chief Conservator of Forests, Visakhapatnam Circle, Visakhapatnam has agreed with the information furnished by the District Forest Officer, Vizianagaram and Recommended the proposal for diversion of forest land. In Part-IV, the Principal Chief Conservator of Forests (FCA) & Nodal Officer, Andhra Pradesh has Recommended the proposal for diversion of forest land.

I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, under Section 2 of Forest (Conservation) Act, 1980 for diversion of 3.63 ha forest land in compartment no.347 & 348 of Chippapalli RF, Ananthagiri (M), Vizianagaram Division for formation of road from Gummakota to Galipadu in favour of Executive Engineer, Panchayat Raj (PIU) Division, Paderu, at the earliest. State Government recommends the proposal in Part-V, which is enclosed herewith.
