Proposal for seeking prior approval of Central Government under Section-2 (ii) of the Forest (Conservation) Act, 1980 in favour of Anil Kumar Sharma Power of Attorney of Late Chandi Prasad Sharma for non-forestry use of 67.352 ha. forest land for Iron & Manganese Ore Mining in village Raikela, Bahamba and Tensa under Bonai Sub-Division in Sundargarh District of Odisha (Online Proposal No.FP/OR/MIN/39199/2019).

Differential payment of NPV in respect of 67.352 ha. of forest land.

Sir,

Whereas the Stage-I approval over 67.352 ha. forest land in respect of Raikela, Bahamba and Tensa Iron & Manganese Ore Mines of Sri Anil Kumar Sharma Power of Attorney of Late Chandi Prasad Sharma has been granted by the MoEF & CC, Govt. of India vide Letter under reference (1).

And whereas the Lessee has already deposited ₹4,94,32,680/- towards NPV over 67.716 ha. of forest land @ ₹7,30,000/- per hectare.

And whereas on Site Inspection by undersigned, the canopy density over 67.352 ha. of forest land proposed to be diverted vide the above said proposal has assessed as 0.50, Eco-Value Class-I, the NPV need to be charged @ ₹14,36,670/- per hectare over the applied forest area of 67.352 ha. for diversion, i.e. 67.352 ha. x ₹14,36,670/- = ₹9,67,62,598/-

And whereas out of the above assessed amount you have earlier deposited ₹4,94,32,680/- @ ₹7,30,000/- per hectare over 67.716 ha. of forest land.

Now therefore, the undersigned, by virtue of authority vested by the Apex Court, hereby demand for payment of ₹4,73,29,918/- (₹9,67,62,598/- (-) ₹4,94,32,680/-) towards differential NPV over 67.716 ha. of forest land within 30 days of issue of this Order.

The NPV of ₹ 4,73,29,918/- (Rupees Four Crore Seventy Three Lakhs Twenty Nine Thousand Nine Hundred Eighteen) only is to be deposited through e-portal of MoEF & CC as provided in the <http://parivesh.nic.in>, and submit the original proof with seal and signature of the issuing Bank to this office for needful.

It is further ordered that in the event of upward revision of NPV, an undertaking to pay the differential amount is to be submitted by the Lessee.
