I am directed to invite your attention to the reference 5th cited, in which the Government of India, Ministry of Environment, Forests & Climate Change have accorded approval in-principle (Stage-I) U/s 2 of Forest (Conservation) Act, 1980, for diversion of 0.30 Ha. of forest land in Compartment No. 85 of Pasuvemula R.F. and Nellikal R.F. of Nagarjunasagar Wildlife Management Division for laying optical fiber cable in forest area along Peddavura to Macherla route, in favour of M/s. Idea Cellular Ltd., subject to fulfillment of certain conditions as stipulated therein.

The Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Hyderabad, in his letter 2nd cited, has submitted condition wise compliance report on the conditions stipulated by Government of India, Ministry of Environment, Forests & Climate Change, while according (Stage-I) approval, and the details of which are as follows:-

It is to further inform that as per the Government of India guidelines of Government of India, Ministry of Environment, Forests and Climate Change, Lr.No.11-9/98-FC(pt.), dt.5.2.2013 for linear projects i.e. laying optical fiber cables underground, the Form-I certificate from the concerned District Collector is not required (for RoFR) excepting for PTGs. The cable is being laid along the existing road and no rights are infringed for laying cables. However, the user agency has given an undertaking to obtain the certificate from the District Collector, Guntur and will submit if it is warranted.
- 4. I am to enclose a copy of the letter together with its enclosures received from Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Hyderabad and to request you to accord Final (Stage-II) approval under Section-2 of Forest (Conservation) Act, 1980 for the project.
