It is informed that the vide reference 6<sup>th</sup> cited the Government of Telangana have accorded **in-principle (Stage. I) approval** under Section 2 of Forest (Conversation) Act, 1980, for diversion of **0.1107 Ha** of Forest land for laying of Gas Pipelines from Vadepally to Bonthapally Industrial area in Jinnaram and Bonthapally RFs of Sangareddy Division Under Sangareddy District in favour of **M/s. Torrent Gas Private Limited, Hyderabad, Subject to compliance of conditions stipulated therein**, which is already communicated to the user agency.

The user agency shall generate challan and transfer funds through online only against the challan generated by producing the same at the designated branch where the user agency has account, in to the Ad-hoc CAMPA account of Telangana.

2. Further, it is to inform that the charges towards expenditure like boundary pillars Big & Small the **M/s. Torrent Gas Private Limited, Hyderabad**, shall remit the CA amount of **Rs. 2.92,500/-** to the District Forest Officer, Sangareddy **Current Account No.37249920410, SBI, Sangareddy Opp. Collectorate, Sangareddy (RTGS/IFSC.No. SBIN0021217).**

Further, the user agency has to comply with the following in accordance with the instructions issued by the GoI, MOEF&CC, New Delhi Vide F.No.7-23-2012-FC, Dated. 24.07.2013 communicated vide PCCF's Ref.No.45921/2001/F4, Dated. 23.08.2013.

1. Publish the entire forest clearances granted to the project proponent for the use of forest land for the non-forest purposes in verbatim along with the condition(s) and safe-guards imposed by the Central Government in two widely circulated daily news paper i.e., one in vernacular language and the other in English.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in-turn has to display the same for (30) days from the date of receipt of this reference.


The User Agency is requested to comply with the other conditions as directed in Stage-I approval and submit the compliance report along with all the required relevant information/documents etc. for obtaining Stage-I approval.
