With reference to the above subject in reference (2) The Government of Karnataka accorded in **"Principle Approval Stage-I"** under Section 2 of the Forest (Conservation) Act, 1980 for diversion of 0.0246 hectare of forest land for the "connectivity road (for residential layout purpose) falls in sy no: 81 of Bachgov village" in favour of Venkatramana Govind Bhat, Tuduguni Village, Sirsi.

Subject to the fulfillment of conditions vide reference (1). In pursuit of the directions issued by the Principal Chief Conservator of Forests (Forest Conservation) and Nodal Officer (FCA), Bengaluru vide reference (3) the following demand notice issued towards the statutory payments of Net Present Value, Cost of Raising plantation of ten times number of tree to be felled.


