It is informed that in the reference 1st cited the GoI, MoEF&CC, Sub Regional Office, Vijayawada has accorded Stage-I approval with certain conditions. In the reference 3rd cited the Prl. Chief Conservator of Forests & HoFF, A.P., Mangalagiri has communicated the orders and issued certain instructions, the copies of the references already communicated to the user agency for necessary action and submission of compliance report on Stage-I conditions. In this regard the demand notice issued vide reference 4th cited is hereby cancelled and revised demand notice issued basing on the orders issued by the GoI, MoEF&CC, New Delhi vide reference 5th cited.

As per the Stage-I approval for diversion of 1.06 ha of forest land for laying and maintaining of 33 KV line (by APEPDCL) beside Narsipatnam under condition no.3 & 5 the user agency has to be deposited the C.A. amount for 2.12 ha in DFL and N.P.V. amount for 1.06 ha to the head of CAMPA account through e-portal <https://parivesh.nic.in> and as per the condition no.8 the extraction charges for trees in the diverted area to be deposited with the State Forest Department i.e., District Forest Officer, Anakapalli. The details are as follows.

Further the user agency as per Stage-I approval condition no.7 a scheme proposal should be prepared for creation and maintenance of plantation of dwarf species (preferably medical plants) in right of way under transmission line to the undersigned for approval and the Raising and Maintenance work should be taken up by the user agency under the guidance of Forest Range Officer, Narsipatnam.

The user agency should pay the Compensatory Afforestation (C.A.), Net Present Value (N.P.V.) amount total **Rs. 32.644054 lakhs** to be deposited through RTGS in CAMPA account, Corporation Bank, CGO Complex, Lodhi Road, New Delhi- 110003 (RTGS/IFSC No.CORP0000371) and the tree extraction charges i.e., **Rs.3.450 lakhs** to be deposited in to the District Forest Officer, Anakapalli account and submit the receipts details along with the Stage-I compliance report and necessary undertakings to the conditions stipulated in the reference 1st cited point wise through Forest Range Officer, Narsipatnam for onward submission to the Chief Conservator of Forests, Visakhapatnam for approval and further process in the matter.
