


Amboli range is located in western ghat. The Western Ghats are one of the globally recognised hotspot biodiversity. Western ghat is a mountain system almost parallel to the western coast of the peninsular India. It is the world biodiversity hotspot spread over India about 1,75,000 Sq. Km. The range starts from mouth of river Tapi and extent southward up to Kanyakumari through the State of Guirat, Maharashtra, Goa, Karnataka, Kerala and Tamil Nadu covering the length up about 1600 Sq. Km. The Western Ghat forms one of the four watersheds of India, feeding the perennial rivers of India that drains almost 40% of Indian, providing water to approximately 245 million peoples. Ghat covers only 6% India's land area, the area is extremely rich in biodiversity containing about 30 % of all plant, fish, hepetofauna, birds and mammal species found in India. At least 325 globally threatened species occur in the Western Ghats. It is also likely that many undiscovered species exist in the Western Ghat. The Ghats are home to over 7,402 species of flowering plant, 1814 species of non-flowering plants, 139 mammal species, 508 birds species, 179 amphibian species, 6000 insect species and 290 freshwater fish species. The region shows high degrees of enemies with 50% of India's amphibians and 67% of fish species and mammals such as the Nilgiri tahr and the lion tailed macaque. In addition, it is to nearly 30% of the world's Asian elephant and 17% of the world's Asian elephant and 17% of the world's tiger population.

For the protection of the flora and fauna of the Western Ghats landscape and the ecosystem services emanating from it, several protected area viz, National Park, Wildlife Sanctuaries, Tiger Reserves and biosphere reserves have been set up.

Amboli is a hill station in south Maharashtra, India. At an altitude of 690 m (2,260 ft) it is the last hill station before the coastal highlands of Goa.

Amboli lies in the Sahayadri Hills of Western India, one of the world's "Eco Hot-Spots and it abounds in unusual flora and fauna. However, as in the other parts of the Sahaydri Hills, denudation of the forest cover and unregulated government-assisted development are gradually ruining a once-pristine environment. Historically, Amboli village came into being as one of the staging posts along the road from Vengurla port to the city of Belgaum, which was extensively used by the British to supply their garrisons in south and central India. The source of the Hiranyakeshi river lies in the hills around Amboli village, and an ancient Shiva temple (called Hiranyakeshwar) sits at the cave where the water emerges. The main attraction for tourists is the incredibly-high rainfall (7 m average, per year) and the numerous waterfalls and mist during the monsoons. Legend has it that there are 108 Shiva temples in and around Amboli, of which only a dozen have been uncovered, one as recently as 2005.

For management purpose Amboli range is divided in to 3 Rounds (Amboli, Devasu & Choukul) and 13 Beats. Nangartas beat is one of them. Nangartas beat is located in the eastern side of Amboli village, the total area of Nangartas is 1003.27 Ha. & rich in flora and fauna. There are many



evergreen and sem-evergreen local tree species found in Nangartas like Anjani, Gela, Jamun, Malava, Awla etc. Alongwith that many faunal species like Leopard, Sambar, wild boar, Elephant, Indian Gaur etc. found in the respective beat.

Regular forest activities carried out in Nangartas beat like plantation, Soil & moisture conservation.
