In this connection, the User Agency is requested to deposit an amount of **Rs. 1,25,21,694/- (Rupees One Crore Twenty Five Lakhs Twenty One thousand Six Hundred and Ninety Four only)** in the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account maintained in the Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003, **through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., <http://parivesh.nic.in> by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at <http://parivesh.nic.in>**

The User Agency has also requested to deposit an amount of **Rs.1,99,600/- (Rupees One lakh Ninety nine Thousand and six hundred only)** into the **PD Account of Forest Divisional Officer, Yellandu**, as given above.

Further, the User Agency is requested to comply with the following in accordance with the instructions issued by the MoEF&CC, GoI vide F.No.7-23-2012-FC, dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests (HoFF) Hyderabad Rc.No.45921/2001/F4, dt.23.08.2013:

1. Publish the entire forest clearances granted to the project component for the purpose of use of forest land for the non-forest purpose in verbatim along with the condition(s) and safe-guards imposed by the Central Government in two widely circulated daily newspaper i.e., one is vernacular language and the other in English.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant

offices of the Government who in-turn has to display the same for 30 days from the date of receipt of this reference.

Further the user agency is also requested to comply with the other conditions as directed in ref 1st and 2nd cited and submit the compliance report on the conditions stipulated by the GOI for obtaining Stage-II (final) approval.
