It is submitted that, vide reference cited, In-Principle (Stage-I) approval accorded for diversion of 1.32Ha of forest land for widening and upgradation of EXISTENCE coad from Markodu to Pedduru of Damartogu RF of Yellandu Division in BadradriKothagudem Districtin favour of EE, PR Division, Bhadrachalamsubject to certain conditions stipulated therein.

Further the CA Non-Forest land area for 70.00 Acres (28.45 Ha) in Sy.No. 67/1 of Venkatapur village of Mudhole Mandal of Nirmal Division & District is identified for diversion of (07) Road Proposals of Panchayath Raj Engineer Department and (01) VTC Proposals of Municipal Commissioner, Nirmal and the amounts are estimated for compensatory levies of Cost of total CA of Non-Forest land area for 70.00 Acres (28.45 Ha), cost of raising of CA, Construction of Boundary Pillars etc., and as per the approved CA scheme the total amount of 694.92941 Lakh Rupees and for the project requirement of 1.32 Ha including all aspects of CA NFL land the details of part payment are as shown below:

The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval.
