Subject: Diversion of **31.692 ha.** Protected Forest land for Vallabhipur(Km 0+900) to Rangola (Km 27+532) SH-39 proposed for strengthening and rehabilitation of existing 2 lane with Paved Shoulders, Hard Shoulders, Construction of Road Side Drain, Re-Construction and Rehabilitation of cross drainage structure, construction of Bus stop with bus bys under second Gujarat State Highway Project(GSHP-II) in Bhavnagar District in favour of Executive Engineer, Project Implementation Unit, R&B Department, Gandhinagar.

Please refer to your letter F.No. 6-GJC043/2019-BHO/303 dated 13.03.2020 on the subject cited above and it is informed that:-



16	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.	User agency has agreed.
17	No additional or new path will be constructed inside the forest area for transportation of construction materials for executive of the project work.	User agency has agreed.
18	The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life whichever is less.	User agency has agreed.
19	The Forest land shall not be used for any purpose other than that specified in the project proposal.	User agency has agreed.
20	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.	User agency has agreed.
21	The State Government and user agency shall comply the provisions of the all Acts, Rules, Regulations, guidelines, NGT order & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.	User agency has agreed.
22	The user agency shall adhere to all rules, regulations, guidelines & acts enforced by State Govt. and Central Govt. for the proposal.	User agency has agreed.
