2. The User agency has been agreed for shall plant and maintain 10X10=100 number of trees to maintain the green cover at the project cost. Planting site for the purpose will be identified by the State Forest Department (Preferably within or in the surrounding area of the project). Only indigenous forest tree species shall be used for such plantation. Trees, if planted on the diverted area, will not be felled without the permission of the State Forest Department, Trees planted in surrounding area, will belong to State Department. (Page no.173/C)
3. The User Agency Sabarmati Gas Limited, Gandhinagar has already payment transferred an amount of Rs.69,817/- towards the cost of Net Present Value in the CAMPA fund. (Page no.193/C)
4. Funds from the user agency has been online payment transferred to the CAMPA fund through e –portal, (Receipt is attached on page no.181/C)
5. The User Agency has generate challan through e-portal and deposited an amount of NPV in the CAMPA fund.
6. The User Agency has undertaken that the forest land shall not be used for any purpose, other than specified in the FCA proposal.
