It is informed that the vide reference 6<sup>th</sup> cited the Government of Telangana have accorded **in-principle (Stage. I) approval** under Section 2 of Forest (Conversation) Act, 1980, for diversion of **0.6228 Ha** of Forest land for laying of approach road to the proposed Municipal Solid Waste (MSW) treatment and disposal facility of GHMC at Nallavally (V) Nallavally RF, Sangareddy District in favour of **Superintendent Engineer (SWM), GHMC, Hyderabad, Subject to compliance of conditions stipulated therein**, which is already communicated to the user agency.

The user agency needs to upload the Revised demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. 1. Publish the entire forest clearances granted to the project proponent for the use of forest land for the non-forest purposes in verbatim along with the condition(s) and safe-guards imposed by the Central Government in two widely circulated daily news paper i.e., one is vernacular language and the other in English.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in-turn has to display the same for (30) days from the date of receipt of this reference.
