Sub: Diversion of revised area of 0.14025 ha (original area 0.18 ha) Protected land in favour of Nehalkumar Hasmukhrai Gandhi for Construction of Access/ approach road to Logistic Park, with Ware House project including underground Water Pipeline, Electricity cable & other ancillary activities at Village Kharivali tarf Paulbar, Tal. Wada, in Palghar district in the state of Maharashtra- regarding.

Sir,

The undersigned is directed to refer to the Government of Maharashtra's letter no. FLD-12A24/C.R.24/F-10 dated 18.03.2024 and APCCF & Nodal Officer (FCA), Maharashtra Letter No. Desk-17/Nodal/Thane/I.D-13269(79)/30/2022-23 dated 05.04.2023 on the above subject seeking prior approval of the Central Government under of Van (Sanrakshan Evam Samvardhan) Adhiniyam, Section-2 1980. After careful examination of the proposal of the State Government, 'in-principle' approval was accorded by the Central Government vide its letter of even number dated 14.05.2024. The Addl. PCCF and Nodal Officer (FCA), Government of Maharashtra, vide his no.Desk-17/FCA-S2/PID-149393/Thane/822/2025-26 07.07.2025 submitted compliance report and requested to grant final approval to the proposal.

After careful consideration of the proposal and compliance report, I am directed to convey the Central Government's 'final approval' under Section- 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, **1980** for diversion of revised area of 0.14025 ha (original area 0.18 ha) Protected land in favour of Nehalkumar Hasmukhrai Gandhi for Construction of Access/ approach road to Logistic Park, with Ware House project including underground Water Pipeline, Electricity cable & other ancillary activities at Village Kharivali tarf Paulbar, Tal. Wada, in Palghar district in the state of Maharashtra subject to the fulfilment of the following conditions:

Legal status of the forest land shall remain unchanged;

- ii. The boundary of the diverted forest land shall be suitably demarcated on ground by the **State Forest Department at the cost of the User Agency**;
- iii. The State Government shall raise and maintain 100 numbers of trees from the amount which has already been realized from the User Agency towards compensatory afforestation;
- iv. Additional amount of the Net Present Value (NPV) of the diverted forest land if, any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency;
- v. No tree felling shall be carried out in the forest area;
- vi. Proper labour camps shall be constructed in the non-forest area and in any case, labour camp shall not be made within the RF area;
- Vii. The State Government, Maharashtra/ Nodal Officer (FCA), Maharashtra shall ensure settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007) before issuing an order for handing over of forest land to the User Agency as per VSS Rule, 2023;
- viii. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
  - ix. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourers after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
  - x. No additional or new path will be constructed inside the forest area for the transportation of construction materials for execution of the project work;
- xi. The forest land proposed to be diverted shall under no circumstances be transferred or sublet to any other agencies, department or person without prior approval of Govt. of India;
- xii. The total forest area utilized for the project shall not exceed **0.14025** ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal;
- xiii. The User Agency and the State Government shall ensure compliance to the all acts, rules, regulation and guidelines of the Ministry, for the time being in force, as applicable to the subject project;
- xiv. Any other condition that the Regional Office, Nagpur may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied by the User Agency;
- xv. In the event of failure to comply with any of the above conditions the User Agency is liable for penal action as per the rules /
