Ministry of Environment, Forests and Climate Change, Government of India, New Delhi conveyed the 'in-principle' approval proposal for diversion of 564.00 ha. of forest land under Section-2 (ii) and 2 (iii) of Forest Conservation Act for development of proposed International Standard Zoo under Forest (Conservation) Act, 1980 subject to fulfillment of the conditions stated in the letter under reference.
