Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government to the User Agency. The User Agency has to abide to that and shall furnished an undertaking to this effect.

After the completion of the payments process, you are requested to submit the compliance report to this office for further needful action.
