In inviting a kind reference to the memo on the subject cited above, this is to inform you that an amount of Rs- 68,68,100/- was demanded to you towards the cost of the Compensatory Afforestation for construction of 132 KV LILO line from existing 132 KV Mohana- Digapahandi SC line to proposed 132/33 KV grid sub-station at R. Udayagiri as per the scheme approved by the Additional Principal Chief Conservator of Forests, Forest Diversion and Nodal Officer, FC Act, Odisha, Bhubaneswar at the prevailing wage rate Rs-298/- per mandays. In the mean while the wage rate has been enhanced to Rs-326/- per mandays. Accordingly, you have submitted the revised scheme for Compensatory Afforestation for construction of 132 KV LILO line from existing 132 KV Mohana- Digapahandi SC line to proposed 132/33 KV grid sub-station at R. Udayagiri at present wage rate i.e., Rs-326/- per mandays and the same has also been approved by the Principal Chief Conservator of Forests, Forest Diversion and Nodal Officer, Forest Conservation Act vide his memo No. 22741/9F (ET)-381/2018 dated 09.11.2022 with a financial outlay of Rs- 1,01,62,510/- (Copy enclosed).

In this connection, as per the approved scheme you are requested to deposit the differential amount of Rs- 32, 94,500/- (Rupees thirty two lakhs ninety four thousand five hundred only) in the Odisha State CAMPA through e-payment mode.
