18	The total Forest area utilized for the project shall not exceed 4.12 hectares and the Forest area diverted shall not be used for any purpose other than those shown in the diversion proposal. 19	All other conditions proposed by the State Government at the time of submission of the proposal to the Government of India shall be complied with by the user agency.	: Agreed by user agency.

22	In the event of failure to comply with any of the above conditions the user agency is liable for penal action as decided by the Additional PCCF (Central) Regional Office, Chennai.	: Agreed by User Agency

In view of the above, the Government are requested to forward the above condition wise compliance report to Government of India for according final (Stage-II) approval under Section-2 of Forest (Conservation) Act, 1980.
