This office has given an "In Principle" approval for diversion of **4.32 ha**. of Protected Forest land for underground laying of Optical Fiber Cables lines in above subjected area vide this office letter dated 09/03/2021 at above ref. letter no.(2).

18/02/2021 of Jio Digital Fibre Pvt. Ltd., Ahmedabad at above ref. no.(3). and exempted to pay NPV and Compensatory afforestation for underground OFC line in ref. letter no.(4) by Additional Principal Chief Conservator of Forests, Land, Gujarat State, Gandhinagar.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions: -

- 11. The permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 12. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 13. The User Agency will have to obtain permission from this office for carrying out any maintenance works in future.
- 14. The User Agency will have to make good the forest land after use/maintenance work. No tree shall be cut.
- 15. The User Agency will be liable to make good any loss to Forests/Environment caused to use of the said land by the user agency.
- 16. The User Agency will seek permission from the Roads & Buildings Department/Science and Technology Department, Sachivalaya, Gandhinagar.
- 17. The Optical Fibre Cables line will be laid underground in a trench of is not more than 1.65 meter depth and width of 0.45 meter in between rows of road side plantation.
- 18. Any other condition, which the Nodal Officer (FCA) may stipulated from time to time.
- 19. The work in the diversion area will have to be done by labour. Machinery shall not be used.
- 20. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per MoEF & CC Guideline F.No.11-42/2017-FC dt 29/01/2018.
- 21. FRA. If Applicable will be complied by the user agency.
