Government of India, Ministry of Environment, Forests and Climate Change, Forest Conservation Division, New Delhi conveyed the 'in-principle' approval for Proposal for diversion of 121.83 ha. of forest land under Forest (Conservation) Act, 1980 for Laser Interferometer Gravitational Wave Observatory in India (LIGO) in Village Dudhala, Anjanwada, Nandgaon, Sawli (B), Tal.Aundha (Nagnath), District Hingoli Maharashtra under Forest (Conservation) Act, 1980 subject to fulfillment of the conditions stated in the letter under reference.
