
Please refer to the State Government letter No. 255/For.I(1)/2022 dated 16.11.2022 and online proposal No. FP/TG/ROAD/147456/2021 seeking prior approval of the Government of India in accordance with Section '2' of Forest (Conservation) Act, 1980 for the above-mentioned project. The project was accorded in-principle approval (Stage-I) by the Central Government vide letter dated 14.12.2022. The State Government vide letter No. 255/For.I(1)/2022 dated 29.05.2023 have reported compliance to the conditions stipulated in the in-principle approval.

After careful consideration of the compliance report submitted by the State Government, I am herewith convey the Central Government's formal approval (*Stage-II*) under Section '2' of the Forest (Conservation) Act, 1980 for diversion of 0.8819 Ha of forest land in Amangal division for Formation of approach road from Nagarjunasagar main road to reach the Vipasyana Meditation Centre and Other Residential Dwellings situated in different Sy.nos of Saheb Nagar (v) of Hayathnagar (M) in Rangareddy District in Favour of Sri. Satya Prakash Rao, subject to the following conditions.


- i. Legal status of the diverted forest land shall remain unchanged.
- ii. Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters and erect chain-link fencing on either side of the road throughout the length of the road to avoid any collision of vehicles and wild animals from the amount already been realized from the User Agency.
- iii. As proposed the State Forest Department shall carry out compensatory afforestation in identified non-forest land over an extent of 1.21 Ha in Sy. No 11/E/1 Badurpur (V), Bashirabad (M), Tandur Division, Vikarabad District, Telangana from the amount already been realized from the User Agency.



- iv. The entire non-forest land proposed for CA over an extent of 1.21 Ha in Sy. No 11/E/1 Badurpur (V), Bashirabad (M), Tandur Division, Vikarabad District, Telangana shall be transferred and mutated in the name of Forest Department and notified as RF/PF. A copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act, shall be submitted by the State Government to this office within 6 months from the date of Stage II approval.
- v. CA area and CA scheme shall not be changed without prior permission of the central government.
- vi. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency.
- vii. No display of advertisement / any such boards shall be carried out in the forest area.
- viii. The User Agency shall ensure no plastic waste / any garbage dumped in the forest area.
- ix. At the entrance of the road, display board clearly indicating the details of diversion and legal status of the land being diverted shall be erected to sensitize the public on the applicability of the rules/regulation to be followed inside the forest area.
- x. The road shall be formed in a width of 40-50 feet (including BT, Shoulders and Drainage) and remaining width of minimum 5 feet on either side of the road shall be used for raising strip plantation.
- xi. Two animal underpasses shall be constructed for seamless movement of animals living in the forest area by the user agency in consultation with the DFO concerned while executing the project work, at the cost of the User Agency. Details of the location of such animal underpasses constructed shall be submitted to this office.
- xii. Construction of culverts/bridges, if any, over the natural streams/rivers/canals shall be done in such a manner that it does not hamper the natural course of water, does not give rise to water-logging, and also does not hamper the movement of wild animals.
- xiii. Roadside cuttings and fillings that require engineering support shall be provided as per the instructions of the DFO concerned so as to stabilize the soil.
- xiv. The dug-out material/overburden shall be dumped outside the forest area. Storage of any material shall not be done in the forest area.
- xv. The road shall be under the administrative control of SFD and shall be allowed to be used by general public without any conditions imposed by the User Agency.
- xvi. The layout plan of the proposal shall not be changed without prior approval of the Central Government.
- xvii. No labour camp shall be established inside the forest area.
- xviii. The total forest area utilized for the project shall not exceed 0.8891 ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal.
- xix. The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the Central Government.
- xx. The User Agency and the State Government shall ensure compliance to provisions of all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project.
- xxi. Any other conditions that the Central Government or DDGF (Central) of Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied with by the User Agency.
- xxii. In the event of failure to comply with any of the above conditions, the User Agency is liable for penal action as per the rules/guidelines issued under FCA, 1980.
