With reference to the aforementioned memo on the captioned subject this is to intimate that, the Principal Chief Conservator of Forests, Forest Diversion and Nodal Officer, FC Act, O/o the PCCF & HoFF, Odisha, Bhubaneswar has technically approved the Penal Compensatory Afforestation Scheme over 282.278 ha of Degraded Forest land *{identified in village Anseikala (108.1647 ha), Jugudidar (52.7059 ha) under Barbil Tahasil and Village- Adala (55.1902 ha), Rugudikasada (26.8263 ha) and Vilage- Gopapur (39.3909 ha) under Banspal Tahasil in Keonjhar Forest Division}* with a total financial outlay of **Rs.10,45,91,900/- (Rupees Ten Crores Forty Five Lakhs Ninety One Thousand Nine Hundred) only** against the forest land to be diverted for Kanpur Irrigation (Canal System) Irrigation Project as per approved One-Time Cost Norm.

Hence, you are requested to deposit the said approved amount of **Rs.10,45,91,900/- (Rupees Ten Crores Forty Five Lakhs Ninety One Thousand Nine Hundred) only** towards the approved Penal Compensatory Afforestation Scheme through e-portal of MoEF&CC as provided in the <https://parivesh.nic.in/> and the proof/evidence of the deposit of fund be submitted to this office for further necessary action at this end.
