Further, the User Agency is requested to deposit the following amount separately through e-portal of MoEF & CC as provided in the <http://parivesh.nic.in>, and submit the original proof with seal and signature of the issuing Bank to this office for needful.

1. An amount of ₹ 10,61,77,425/- (₹ 9,39,000/- (X) 113.075 ha.) (Rupees Ten Crore Sixty One Lakh Seventy Seven Thousand Four Hundred Twenty Five) only towards **Net Present Value (NPV)** as per **Condition No.A (2)** of the Stage-I approval order within 30 days from the issue of this Letter.
2. An amount of ₹ 6,01,91,400/- (Rupees Six Crore One Lakh Ninety One Thousand Four Hundred) only towards cost of **Compensatory Afforestation and Additional Compensatory Afforestation** as per approved revised financial outlay submitted by the CF (Nodal), Bhubaneswar vide Letter under reference (2).

3. An amount of ₹ 4,09,36,500/- (Rupees Four Crore Nine Lakh Thirty Six Thousand Five Hundred) only towards cost of **Catchment Area Treatment Plan** as per approved revised financial outlay submitted by the CF (Nodal), Bhubaneswar vide Letter under reference (2).
