With reference to the subject above, it is to note that the payment of NPV amounting to Rs. 4,49,69,362.20/- for the above project was conveyed vide this No.6/FCA-78/ROAD/DCFS/TECH/2022-23/1964 dated 18/11/2022.

With respect to the Compensatory Afforestation, the CA Scheme received from Karnataka Forest Department vide No. KFD/HOFF/A52K(MISC)/3/2018-FC dated 12/10/2023 and the Dy. Conservator of Forests, Monitoring and Evaluation, Panaji informed to issue Demand Note to the User Agency for the payment of CA an amounting Rs.10,28,07,200/- as submitted a letter by the Karnataka Forest Department. The details of amount to be deposited towards Compensatory Afforestation are as under:-
