The non-forest land to be identified for compensatory afforestation shall be transferred and mutated in the name of Forest Department and notified as PF/RF prior to stage-II approval ensuring its suitability. A copy of the original notification declaring the nonforest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, will be submitted by the State Government prior to Stage-II approval.

GAIL India Limited is a Maharatna PSU under Central Government MoPNG and as per above guidelines, compliance against CA over DFL can for Stage-II/Final be submitted approval.

In view of above, demand note cited under reference no 5 was uploaded in PARIVESH portal which was rejected by Nodal office, Nagpur as per reasons cited under reference no. 6. i.e. stating "Separate request letter should be submitted to Government of India and sought direction". Accordingly, necessary clarification was sought from RO office, MoEFCC, Nagpur as per letter cited under reference no. 4 and again the demand note for CA was uploaded for approval. But again the proposal was returned by Nodal office, Nagpur as per reasons cited stating "As per Hon'ble Supreme Court of India on 3rd Feb 2025 issued an interim order in writ petition(1)(civil)No(s) 1164 2023", the said demand rejected".

Further, as per latest MoEFCC guidelines and clarifications issued on 17.03.2025 under subject "Permitting double the degraded forest land in lieu of non-forest land for certain projects taken up by CPSU/SPSU and other government agencies" cited under reference no. 3 regarding CA vis-à-vis direction passed by Hon'ble Supreme Court in which it is informed that,

"As per the provisions of the Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024, there is no requirement of certificate from the State Government certifying the non-availability of non-forest land for the projects of Central PSU/entities and captive coal blocks of the state PSUs"

Accordingly, it is requested to process the demand note for compensatory afforestation which is uploaded in the PARIVESH.1 portal considering CA on DFL for approval as per above new guidelines issued by MoEFCC.

However, as per the MoEFCC guidelines dated 17.12.2024 cited at reference 3, following clarification was issued at Clause v. of the guideline:

"With regards to the applicability of the provisions of the Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024 in respect of proposals of the Central Agencies/PSUs and captive coal blocks of the State PSUs which were granted 'in-principle' approval stipulating CA over non-forest land, the following clarification is given in this regard:

a. Proposals, which were submitted by the States/UTs before notification of Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024, along with the proposal of raising CA over degraded forest land (DFL) and were granted 'in-principle' approval stipulating CA over non-forest land (NFL), shall be allowed to submit compliance of 'in-principle' approval along with CA proposal over DFL in lieu of NFL. The Central Government will consider and grant final approval in such cases stipulating CA over DFL."

This is to inform that GAIL (India) Limited is a Central PSU under MoPNG and we had applied for forest clearance proposal on 30/06/2022 with CA over degraded forest land (DFL) which is before the notification of Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024 and was granted in-principle approval on dated 14.05.2024. Thus, the proposal comes under Clause v (a) and should be dealt as per revised guidelines.

Further, in accordance to the aforesaid Clause v (a) of MoEFCC guidelines dated 17.12.2024, we had requested for demand note from DFO, Alibag vide letter at Reference no. 4 considering CA over DFL land. Thereafter DFO, Alibag had issued demand note cited at reference no. 5.

However, the demand note as submitted in the Parivesh Portal has been rejected by Nodal Officer, Nagpur email copy cited at Reference-6 with following reason for rejection:

"As per mentioned condition No. 3 of In-principle approval, the Government of India has stipulated condition, the suitable non-forest land equivalent to diverted forest land shall be identified if the relaxation made under guidelines dated 17/12/2024, separate request letter should be submitted to Government of India and sought direction."

Therefore, it is hereby requested to provide clarification with respect to our case and allow for submission of compliance of 'in-principle' approval along with CA proposal over DFL in lieu of NFL as submitted in the original proposal, under the guidelines dated 17/12/2024.

Please refer to the Government of Maharashtra letter no FLD-2023/C.R.-325/F-10 dated 19.01.2024 and APCCF & Nodal Officer letter No Desk-17/Nodal /Thane/ID-157648/240/2024-25 dated 02.05.2024 and online application No.FP/MH/Pipeline/157648/2022 seeking prior approval of the Central Government under Section-2 (1) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam,1980.

After careful consideration of the proposal submitted by the State Government, I am directed to convey the Central Government's *In-principle* approval under Section '2' (1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam,1980 for diversion of 3.4151 ha of forest land in favour of GAIL India Limited for Construction of underground MS pipeline 700mm concrete encasing for regular Water Supply Line from MIDC Water Treatment plan, Poynad to GAIL (India) Ltd, User for PDH PP Plant of Tadwagale, Dalvi Khoroshi, Kune and Beloshi villages of Taluka Alibag in Raigad District in the state of Maharashtra, subject to the fulfilment of the following conditions:

- 1. The legal status of forest land shall remain unchanged;
- The demarcation of the proposed forest area shall be carried out at suitable places as per the direction of the DCF concerned at the cost of the User Agency;
- 3. The suitable non forest area equivalent to the diverted forest area shall



be identified and CA scheme shall be prepared as per the provision made under Van (Sanrakshan Evam Samvardha) Rules, 2023 and all other documents like kml, map, site suitability certificate, CA scheme etc shall be submitted along with the compliance report and shall ensure to upload all above mentioned documents in the online application;

- 4. The non-forest land to be identified for compensatory afforestation shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval after ensuring its suitability. A copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, will be submitted by the State Government prior to Stage-II approval;;;
- 5. The State Government shall charge the Net Present Value of the diverted forest land measuring 3.4151 ha from the User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995 and Ministry's guideline.
- 6. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect:
- 7. All the funds received from the User Agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/);
- 8. Tree feeling shall be carried out in the forest area wherever necessary under the strict supervision of the State Forest Department. Tree felling shall be carried out at the cost of the User Agency;
- 9. The State / UA shall ensure all other approvals / permission under relevant rules / regulation, if any required prior to commencement of the project work.
- 10. Proper labour camps shall be constructed in the non-forest area and in any case, labour camp shall not be made within the RF area;
- 11. After ensuring settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (2 of 2007) and compliance to all such conditions, the State Government shall issue order for working permission or diversion as the case may be;
- 12. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
- 13. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourers after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel:
- 14. No additional or new path will be constructed inside the forest area for the transportation of construction materials for execution of the project work;

- 15. The forest land proposed to be diverted shall under no circumstances be transferred or sublet to any other agencies, department or person without prior approval of Govt. of India:
- 16. The total forest area utilized for the project shall not exceed3.4151 ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal. The User Agency shall furnish an undertaking to this effect:
- 17. The User Agency and the State Government shall ensure compliance to the all acts, rules, regulation and guidelines of the Ministry, for the time being in force, as applicable to the subject project;
- 18. Any other condition that the Regional Office, Nagpur may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied by the User Agency;
- 19. In the event of failure to comply with any of the above conditions the User Agency is liable for penal action as per the rules / guidelines issued under <u>Van(Sanrakshan Evam Samvardhan) Adhiniyam. 1980</u>;
- 20. The State Government shall process and submit compliance report on the above conditions through online (https://parivesh.nic.in/).

After receipt of the Compliance report on the above conditions, the proposal will be considered to accord final approval. The in-principle approval shall be valid for a period of 2 years from the date of issue of the same. In the event of non-compliance of the above conditions within the stipulated period, this in-principle approval shall be deemed to be null and void;

Madam/Sir,

I am directed to refer to the above subject and to inform that based on the references received from the Ministry of Mines, and Ministry of Coal, the provisions related to raising of compensatory afforestation, as envisaged in the Van (Sanrakshan Evam Samvardhan) Rules, 2023 as amended on 20.09.2024, have been reviewed by the Ministry and after due deliberations, the Central Government, in accordance with the provisions of section 3C of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 hereby issues the following clarifications:

- i. Provisions of Rule 14(1) of the Van (Sanrakshan Evam Samvardhan) Rules, 2023, provides that the non-forest land identified for raising Compensatory Afforestation (CA) is to be notified as Protected Forests before final approval (Stage-II) approval is granted by the Central Government. However, in cases where non-forest land identified for CA has been transferred and mutated in favour of the State Forest Department (SFD), the Central Government may accord final approval keeping in view the fact that provisions of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 become applicable on such lands being entered as forest in government record/record of rights.
- ii. In such cases, referred in para (i) above, the non-forest land forest land proposed for CA, shall be notified as Protected Forest under section 29 of the Indian Forest Act, 1927 of local forest Act before handing over of forest land to the User Agency by the State Government. The Nodal Officer, after notification of such non-forest lands, shall upload a copy of said notification on the PARIVESH portal.
- iii. For the purpose of rule 13(4)(a) of the States or Union territory Administrations, having forest area more than 33% of their total geographical area, concerned State Government/UT Administrationmay authorise a suitable officer to issue certificate of non-availability of the suitable non-forest land for raising CA.
- iv. As per the provisions of the Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024, projects of Central Government entities/CPSU and captive coal blocks of the State PSUs are eligible for raising CA over degraded forest land which will be double in extent of the forest land being diverted. Accordingly, the State Government/UT shall not insist for providing non-forest land as CA unless in cases wherein the Central Government

Agencies/CPSUs or State Government PSUs with captive coal blocks are forthcoming to provide non-forest land available with them as CA or the State Government/UT Administration is willing to provides non-forest land on such terms and condition which is agreed by the Central Government Agencies/CPSUs or State Government PSUs in case of captive coal blocks.

- v. With regards to the applicability of the provisions of the Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024 in respect of proposals of the Central Agencies/PSUs and captive coal blocks of the State PSUs which were granted 'in-principle' approval stipulating CA over non-forest land, the following clarification is given in this regard:
 - a. Proposals, which were submitted by the States/UTs before notification of Van (Sanrakshan Evam Samvardhan) Amendment Rules, 2024, along with the proposal of raising CA over degraded forest land (DFL) and were granted 'in-principle' approval stipulating CA over non-forest land (NFL), shall be allowed to submit compliance of 'in-principle' approval along with CA proposal over DFL in lieu of NFL. The Central Government will consider and grant final approval in such cases stipulating CA over DFL.
 - b. Proposals, which were submitted by the States/UTs along with CA proposal over non-forest land and were granted 'in-principle' approval stipulating CA over non-forest land (NFL), can also be allowed to submit compliance of 'in-principle' approval along with CA proposal over DFL provided the non-forest land proposed for CA is not transferred and mutated in favour of the State Forest Department. In such cases, the Central Government or its Regional Office, based on the request of the State/UT Government or user agency, shall amend the condition of in-principle approval to raise CA over DFL on a case to case basis and subsequently the User Agency shall submit the compliance of in-principle for the obtaining the 'final' approval.

In view of the above, the State Government and Union territory Administrations are requested to take into consideration the guidelines mentioned hereinabove while considering the proposals submitted under section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.
